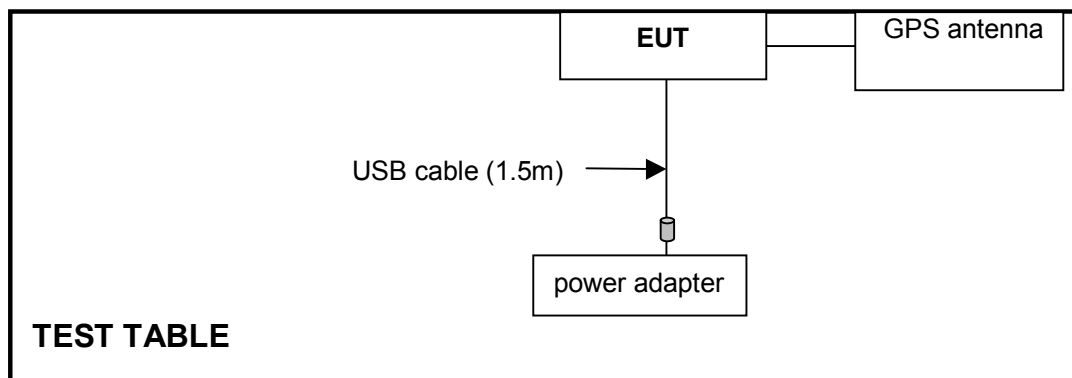

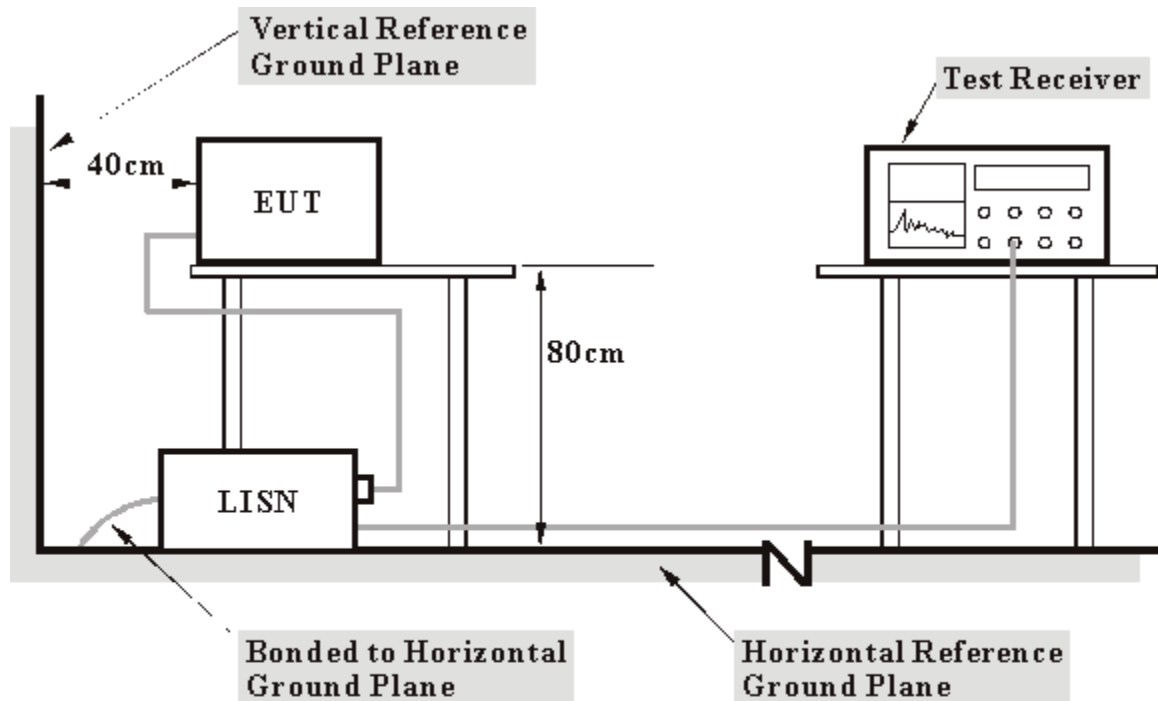
4.1.3 TEST PROCEDURES

- a. The EUT was placed 0.4 meters from the conducting wall of the shielded room with EUT being connected to the power mains through a line impedance stabilization network (LISN). Other support units were connected to the power mains through another LISN. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.
- c. The frequency range from 150kHz to 30MHz was searched. Emission levels under Limit - 20dB was not recorded.

- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

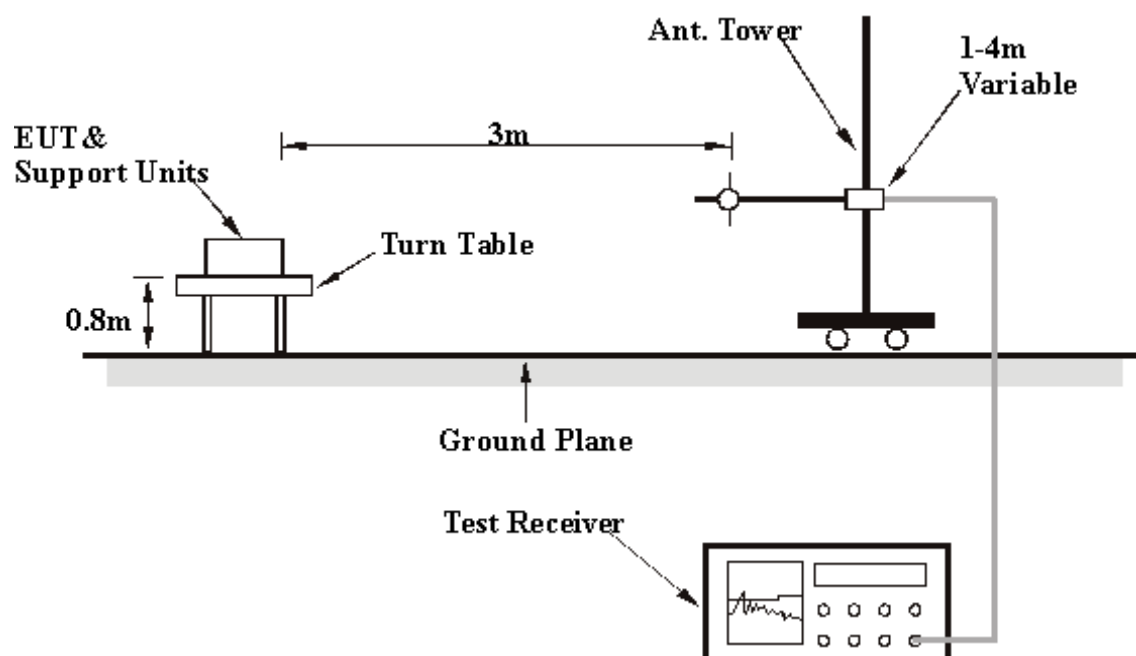

4.8.3 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer via a low lose cable. Set both RBW and VBW of spectrum analyzer to 100 kHz with suitable frequency span including 100 MHz bandwidth from band edge. The band edges was measured and recorded.

4.8.5 EUT OPERATING CONDITION

The software provided by client enabled the EUT to transmit and receive data at lowest, middle and highest channel frequencies individually.

4.8.6 TEST RESULTS

The spectrum plots are attached on the following 2 pages. D2 line indicates the highest level, D1 line indicates the 20dB offset below D2. It shows compliance with the requirement in part 15.247(C).

Note - The delta method is only used up to 2 MHz away from the restricted bandage, The radiated emissions which located in other restricted frequency band, the result, please refer to 4.2.

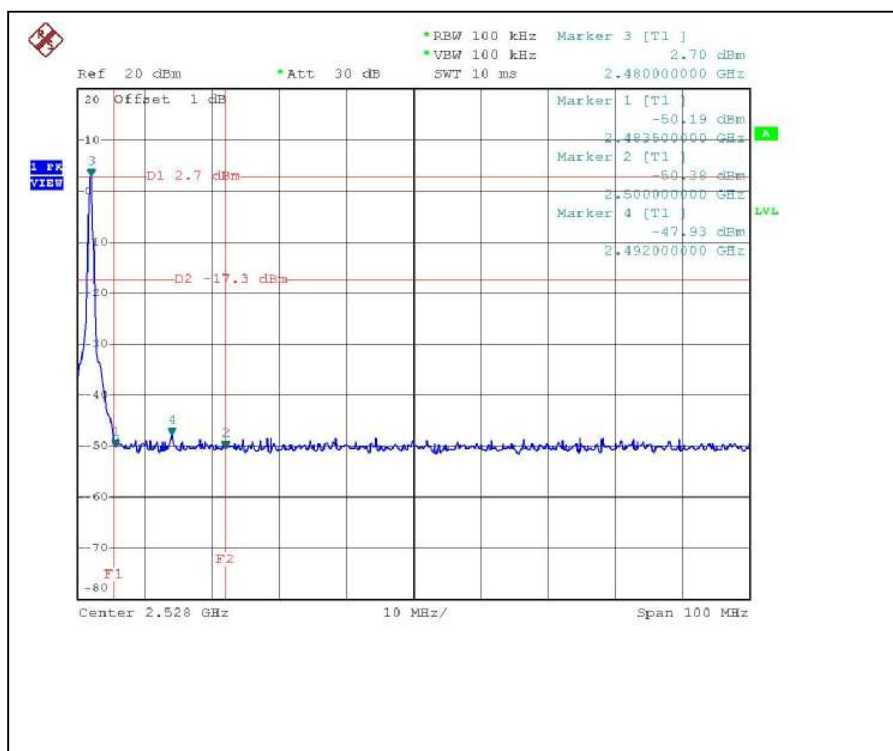
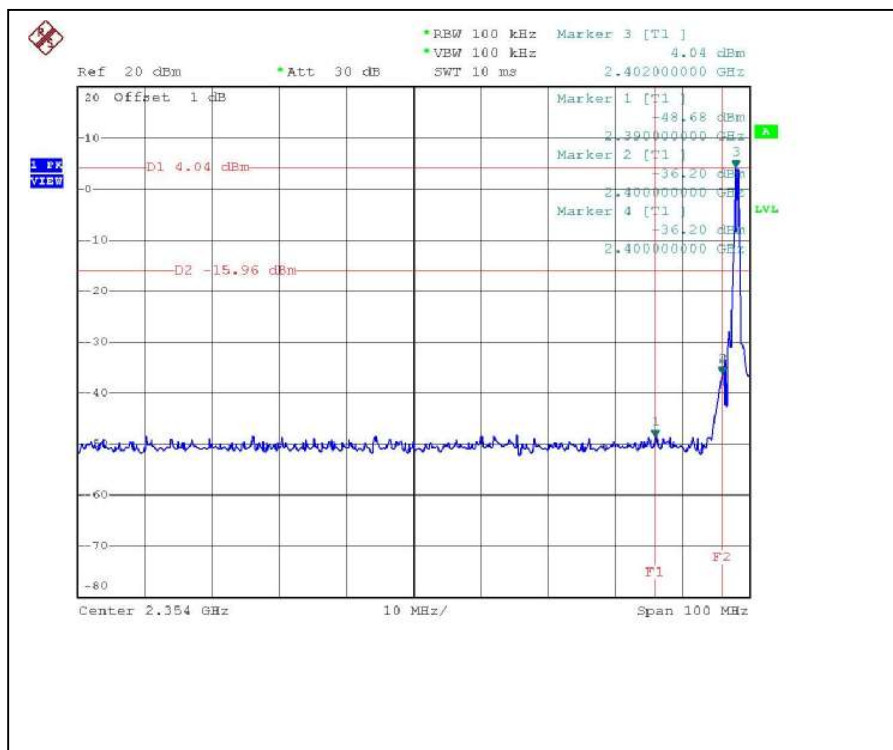
The band edge emission plot on the following first page show 52.72dB delta between carrier maximum power and local maximum emission in restrict band (2.3900GHz). The emission of carrier strength list in the test result of channel 0 at the item 4.2 is 100.40dBuV/m, so the maximum field strength in restrict band is $100.40 - 52.72 = 47.68$ dBuV/m which is under 74 dBuV/m limit.

The band edge emission plot on the following first page shows 52.89dB delta between carrier maximum power and local maximum emission in restrict band (2.4835GHz). The emission of carrier strength list in the test result of channel 78 at the item 4.2 is 102.0dBuV/m, so the maximum field strength in restrict band is $102.0 - 52.89 = 49.11$ dBuV/m which is under 74 dBuV/m limit.

The band edge emission plot on the following second page shows 52.72 dB delta between carrier maximum power and local maximum emission in restrict band (2.3900GHz). The band edge emission plot on the following second page shows 52.89dB delta between carrier maximum power and local maximum emission in restrict band (2.4835GHz). The emission of carrier strength list in the test result of channel 78 at the item 4.2 is 72.0dBuV/m, so the maximum field strength in restrict band is $72.0 - 52.89 = 19.11$ dBuV/m which is under 54 dBuV/m limit.

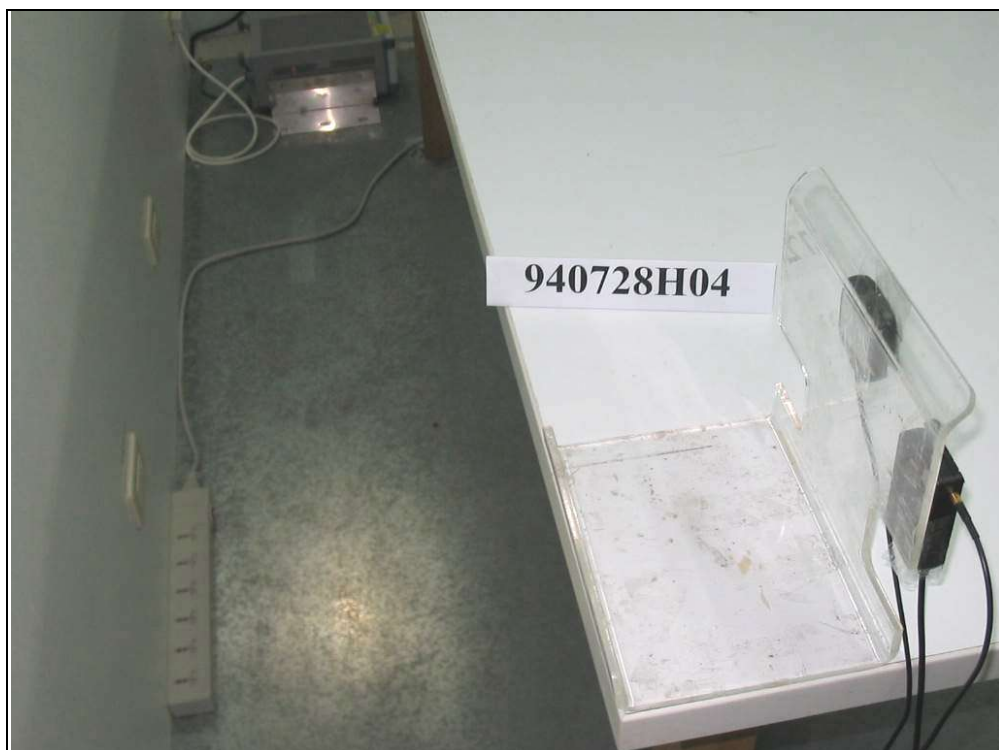
