

## 5. Test results

## 5.1 Antenna Requirement

### 5.1.1 Regulation

According to §15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

## 5.2.1 Regulation

15.225 (a) The field strength of any emission within the band 13.553-13.567 Mb shall not exceed 15, 848 microvolts/meter at 30 meters.

## 5.2.2 Measurement Procedure

Test Procedure The Radiated Electric Field Strength intensity has been measured on semi anechoic chamber with a ground plane and at a distance of 3m.

Frequency : From 9 kt to 30 Mt at distance 3m The EUT was rotated a full revolution in order to obtain the maximum value of the electric field intensity.

Frequency : From 30 Mb to 1 Gb at distance 3m The measuring antenna height varied between 1 and 4m and EUT was rotated a full revolution in order to obtain the maximum value of the electric field intensity.

The measurements were performed for both vertical and horizontal antenna polarization.

Measurements were performed with a QP, PK, and AV detector. The radiated emission measurements were made with the following detector function of the test receiver (below 1 GHz).

### 5.4.2 Measurement Procedure

The spurious emissions from the EUT will be measured on an 10 m Anechoic chamber in the frequency range of 9 kHz to 30 MHz using a tuned receiver and a shielded loop antenna.

The antenna was positioned 3, 10 or 30 meters horizontally from the EUT.

Measurements haver been made in all three orthogonal axes and the shielded loop antenna was rotated to locate the maximum of the emissions.

In the case where larger measuring distances are required the results will extrapolated based on the values measuring on the closer distances according to Section 15.31 (f) (2) [2].

The final measurement will be performed with an EMI Riceiver set to Quasi Peak detector except for the frequency bands 9 kHz to 90 kHz and 110 to 490 kHz where an average detector will be used according to Section 15.209 (d) [2].

The final lever, expressed in  $dB\mu V/m$ , is arrived at by taking the reading from the EMI receiver (Level  $dB\mu V$ ) and adding the antenna correction factor and cable loss fator (Factor dB) to it. This result then has to be compared with the relevant FCC limit. The resolution bandwith during the measurement is as follows: 9 kHz - 150 kHz: ResBW: 200 Hz

150 kHz - 30 MHz: ResBW: 9 kHz

The preliminary radiated measurements were performed to determine the frequency producing the maximum emissions in an anechoic chamber at a distance of 3 meters.

The EUT was placed on the top of the 0.8 meter height, 1 x 1.5 meter non-metallic table. To find the maximum emission levels, the height of a measuring antenna was changed and the turntable was rotated 360°.

The antenna polarization was also changed from vertical to horizontal. The spectrum was canned from 30 to 1 000 Mb using the BILOG antenna. To obain the final measurement data, the EUT was arranged on a turntable situated on a 10 m chamber. The EUT was tested at a distance 3 meters.

Each frequency found during preliminary measurements was re-examined and investigated. The testreceiver system was set up to average, peak, and quasi-peak detector function with specified bandwidth.

### 5.5 Frequency tolerance

### 5.5.1 Regulation

15.225 (e) The frequency tolerance of the carrier signal shall be maintained within  $\pm 0.01$  % of the operating frequency over a temperature variation of -20 degrees to +50 degrees C at normal supply voltage, and for a variation in the primary supply voltage from 85 % to 115 % of the rated supply voltage at a temperature of 20 degrees C. For battery operated equipment, the equipment tests shall be performed using a new battery.

5.6 Conducted Emission

### 5.6.1 Regulation

According to §15.207(a), for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 klb to 30 Mb, shall not exceed the limits in the following table, as measured using a 50  $\mu$ H/50  $\Omega$  line impedance stabilization network (LISN).

Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower limit applies at the boundary between the frequency ranges.

According to §15.107(a), for unintentional device, except for Class A digital devices, line conducted emission limits are the same as the above table.

#### 5.6.2 Measurement Procedure

- 1) The EUT was placed on a wooden table of size, 1 m by 1.5 m, raised 80 cm in which is located 40 cmaway from the vertical wall and 1.5m away from the side wall of the shielded room.
- 2) Each current-carrying conductor of the EUT power cord was individually connected through a  $50\Omega/50\mu$ H LISN, which is an input transducer to a Spectrum Analyzer or an EMI/Field Intensity Meter, to the input power source.
- 3) Exploratory measurements were made to identify the frequency of the emission that had the highest amplitude relative to the limit by operating the EUT in a range of typical modes of operation, cable position, and with a typical system equipment configuration and arrangement. Based on the exploratory tests of the EUT, the one EUT cable configuration and arrangement and mode of operation that had produced the emission with the highest amplitude relative to the limit was selected for the final measurement.
- 4) The final test on all current-carrying conductors of all of the power cords to the equipment that comprises the EUT (but not the cords associated with other non-EUT equipment is the system) was then performed over the frequency range of 0.15 MHz to 30 MHz.
- 5) The measurements were made with the detector set to PEAK amplitude within a bandwidth of 10 kb or to QUASI-PEAK and AVERAGE within a bandwidth of 9 Wz. The EUT was in transmitting mode during the measurements.



## 5.7 Occupied Bandwidth

#### 5.7.1 Regulation

The emission bandwidth (x dB) is defined as the frequency range between two points, one above and one below the carrier frequency, at which the spectral density of the emission is attenuated x dB below the maximum in-band spectral density of the modulated signal. Spectral density (power per unit bandwidth) is to be measured with a detector of resolution bandwidth in the range of 1% to 5% of the anticipated emission bandwidth, and a video bandwidth at least 3x the resolution bandwidth.

When the occupied bandwidth limit is not stated in the applicable RSS or reference measurement method, the transmitted signal bandwidth shall be reported as the 99% emission bandwidth, as calculated or measured.

#### 5.7.2 Measurement procedure

- The transmitter shall be operated at its maximum carrier power measured under normal test conditions.
- The span of the analyzer shall be set to capture all products of the modulation process, including the emission skirts.
- The resolution bandwidth (RBW) shall be in the range of 1% to 5% of the occupied bandwidth (OBW) and video bandwidth (VBW) shall be approximately 3x RBW.

A peak, or peak hold, may be used in place of the sampling detector as this may produce a wider bandwidth than the actual bandwidth (worst-case measurement). Use of a peak hold may be necessary to determine the occupied bandwidth if the device is not transmitting continuously.

The trace data points are recovered and are directly summed in linear power level terms. The recovered amplitude data points, beginning at the lowest frequency, are placed in a running sum until 0.5% of the total is reached and that frequency recorded. The process is repeated for the highest frequency data points (starting at the highest frequency, at the right side of the span, and going down in frequency). This frequency is then recorded.

The difference between the two recorded frequencies is the 99% occupied bandwidth.


