### SYSTEM TEST CONFIGURATION

# 2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

#### 2.2. EUT Exercise

An engineering test mode (software/firmware) that applicant provided was utilized to manipulate the EUT into transmit, selection of the test channel, and modulation scheme.

#### 2.3. Test Procedure

# 2.3.1 Conducted Emissions

The EUT is a placed on as turn table which is 0.8 m above ground plane. According to the general criterion in Section 7.1 of ANSI C63.4:2009 & 6.2 ANSI 63.10:2009. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz, and the measurement procedure 7.3 in ANSI 63.4:2009 & 6.2.2, and 6.2.3 in ANSI 63.10:2009 is followed to carry out the test. The CISPR Quasi-Peak and Average detector mode is employed according to §15.107

#### 2.3.2 Radiated Emissions

The EUT is a placed on as turn table which is 0.8 m above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes and measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna according to the requirements in Section 8 and 13 and of ANSI C63.4:2009, & Section 6.3, 6.4, 6.5, and 6.6 of ANSI 63.10:2009.ANSI C63.10:2009.and DA 00-705.

Fig. 2-1 Radiated Emission




Fig. 2-2 Conducted (Antenna Port) Configuration















## 10. SPURIOUS RADIATED EMISSION TEST

# 10.1. Standard Applicable

According to §15.247(d),

Emission at antenna port:

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. In addition, radiated emissions which fall in the restricted bands of Table 3 must also comply with the radiated emission limits specified in Tables 5 and 6 of RSS-GEN.
