












Fig.3 EUT Back side to flat phantom






Fig.4 EUT Back-1 side to flat phantom






Fig.5 EUT Top-1 side to flat phantom






Fig.6 EUT Top-2 side to flat phantom






Fig.7 EUT Right side to flat phantom






Fig.8 EUT Left side to flat phantom






Fig.9 EUT Front side to flat phantom




Fig.12 Antenna location of EUT
