## 4.3 DESCRIPTION OF TEST MODES

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

The Transmitter was operated in the normal operating mode. The TX frequency was fixed which was for the purpose of the measurements.

Test of channel included the lowest and middle and highest frequency to perform the test, then record on this report.

Those modulation ASK were used for all test.

Pre-defined engineering program for regulatory testing used to control the EUT for staying in continuous transmitting and receiving mode is programmed.

# 7 SETUP OF EQUIPMENT UNDER TEST

#### 7.1 RADIO FREQUENCY TEST SETUP 1

The NFC component's antenna ports(s) of the EUT are connected to the measurement instrument per an appropriate attenuator. The EUT is controlled by PC/software to emit the specified signals for the purpose of measurements.



# 7.2 RADIO FREQUENCY TEST SETUP 2

The test site semi-anechoic chamber has met the requirement of NSA tolerance 4 dB according to the standards: ANSI C63.10. The test distance is 3m.The setup is according to the requirements in Section 13.1.4.1 of ANSI C63.10-2013 and CAN/CSA-CEI/IEC CISPR 22.


#### Below 30MHz:

The EUT is placed on a turntable 0.1 meters above the ground in the chamber, 3 meter away from the antenna (loop antenna). The Antenna should be positioned with its plane vertical at the specified distance from the EUT and rotated about its vertical axis for maximum response at each azimuth about the EUT. The center of the loop shall be 1 m above the ground. For certain applications, the loop antenna plane may also need to be positioned horizontally at the specified distance from the EUT.

#### Above 30MHz:


The EUT is placed on a turntable 0.1 meters above the ground in the chamber, 3 meter away from the antenna. The maximal emission value is acquired by adjusting the antenna height, polarisation and turntable azimuth. Normally, the height range of antenna is 1 m to 4 m, the azimuth range of turntable is 0° to 360°, and the receive antenna has two polarizations Vertical (V) and Horizontal (H).

#### (a) Radiated Emission Test Set-Up, Frequency Below 30MHz










#### 7.3 CONDUCTED EMISSION TEST SETUP

The mains cable of the EUT (maybe per AC/DC Adapter) must be connected to LISN. The LISN shall be placed 0.8 m from the boundary of EUT and bonded to a ground reference plane for LISN mounted on top of the ground reference plane. This distance is between the closest points of the LISN and the EUT. All other units of the EUT and associated equipment shall be at least 0.8m from the LISN.


Ground connections, where required for safety purposes, shall be connected to the reference ground point of the LISN and, where not otherwise provided or specified by the manufacturer, shall be of same length as the mains cable and run parallel to the mains connection at a separation distance of not more than 0.8 m.

According to the requirements in ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz using CISPR Quasi-Peak and average detector mode.

#### 8.1 OCCUPIED BANDWIDTH

#### 8.1.1 Applicable Standard

#### 8.1.2 Conformance Limit

#### 8.1.3 Test Configuration

Test according to clause 7.1 radio frequency test setup

#### 8.1.4 Test Procedure

The EUT was operating in transmit mode and controlled its channel. Printed out the test result from the spectrum by hard copy function.

The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.

Set to the maximum power setting and enable the EUT transmit continuously

Set RBW = 1% occupied bandwidth.

Set the video bandwidth (VBW) =3 times RBW.

Set Span= approximately 2 to 3 times the occupied bandwidth

Set Detector = Peak.

Set Trace mode = max hold.

Set Sweep = auto couple.

The EUT should be transmitting at its maximum data rate. Allow the trace to stabilize. Use the marker-to-peak function to set the marker to the peak of the emission. Use the marker-delta function to measure 99% down one side of the emission. Reset the markerdelta function, and move the marker to the other side of the emission, until it is (as close as possible to) even with the reference marker level. The marker-delta reading at this point is the 99% bandwidth of the emission.

If this value varies with different modes of operation (e.g., data rate, modulation format, etc.), repeat this test for each variation.



#### 8.2 FREQUENCY STABILITY

#### 8.2.1 Applicable Standard

According to FCC Part 2.1055

#### 8.2.2 Conformance Limit

According to part 15.225(e), The frequency tolerance of the carrier signal shall be maintained within  $\pm 0.01\%$  of the operating frequency over a temperature variation of -20 degrees to +50 degrees C at normal supply voltage, and for a variation in the primary supply voltage from 85% to 115% of the rated supply voltage at a temperature of 20 degrees C. For battery operated equipment, the equipment tests shall be performed using a new battery.

#### 8.2.3 Test Configuration

Test according to clause 7.1 radio frequency test setup

#### 8.2.4 Test Procedures

Connect the EUT to frequency analyzer via the antenna connector.

EUT was placed at temperature chamber and connected to an external power supply.

Temperature and voltage condition shall be tested to confirm frequency stability.

(a) Frequency measurements shall be made at the extremes of the specified temperature range and at intervals of not more than 10° centigrade through the range. A period of time sufficient to stabilize all of the components of the oscillator circuit at each temperature level shall be allowed prior to frequency measurement. The short-term transient effects on the frequency of the transmitter due to keying (except for broadcast transmitters) and any heating element cycling normally occurring at each ambient temperature level also shall be shown. Only the portion or portions of the transmitter containing the frequency determining and stabilizing circuitry need be subjected to the temperature variation test.

(b) The frequency stability shall be measured with variation of primary supply voltage as follows:

(1) Vary primary supply voltage from 85 to 115 percent of the nominal value for other than hand carried battery equipment.

(2) For hand carried, battery powered equipment, reduce primary supply voltage to the battery operating end point, which shall be specified by the manufacturer.

## 8.3.3 Test Configuration

Test according to clause 7.2 radio frequency test setup

#### 8.3.4 Test Procedure

This test is required for any spurious emission that falls in a Restricted Band, as defined in Section 15.205. It must be performed with the highest gain of each type of antenna proposed for use with the EUT. Use the following spectrum analyzer settings:

The EUT was placed on a turn table which is 0.1m above ground plane.

Maximum procedure was performed on the highest emissions to ensure EUT compliance.

Span = wide enough to fully capture the emission being measured

RBW = 100 kHz for f < 1 GHz(30MHz to 1GHz), 200Hz for f<150KHz(9KHz to 150KHz), 9KHz for f<30MHz(150KHz to 30KHz)

 $\mathsf{VBW} \geq \mathsf{RBW}$ 

Sweep = auto

Detector function = peak

Trace = max hold

Follow the guidelines in ANSI C63.10-2013 with respect to maximizing the emission by rotating the EUT, measuring the emission while the EUT is situated in three orthogonal planes (if appropriate), adjusting the measurement antenna height and polarization, etc. A pre-amp and a high pass filter are required for this test, in order to provide the measuring system with sufficient sensitivity. Allow the trace to stabilize. The peak reading of the emission, after being corrected by the antenna factor, cable loss, pre-amp gain, etc., is the peak field strength, which must comply with the limit specified in Section 15.35(b). Submit this data.

Now set the VBW to 10 Hz, while maintaining all of the other instrument settings. This peak level, once corrected, must comply with the limit specified in Section 15.209. If the dwell time per channel of the hopping signal is less than 100 ms, then the reading obtained with the 10 Hz VBW may be further adjusted by a "duty cycle correction factor", derived from 20log(dwell time/100 ms), in an effort to demonstrate compliance with the 15.209 limit. Submit this data.

Repeat above procedures until all frequency measured was complete.





■ Spurious Emission below 30MHz (150KHz to 30MHz)










■ Spurious Emission below 1GHz (30MHz to 1GHz)










# **9 ANTENNA APPLICATION**

#### 9.1.1 Antenna Requirement

Standard	Requirement
FCC CRF Part 15.203	An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of §15.211, §15.213, §15.217, §15.219, or §15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with §15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this part are not exceeded.

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.
