### 2.1.1. Friis transmission formula: $Pd = (Pout*G)/(4*pi*R^2)$

Where Pd = power density in mW/cm²

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

Pd the limit of MPE, 1 mW/cm². If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance where the MPE limit is reached.

Bluetooth + CDMA:  $(0.000 488 / 1) + (0.193 968 / 0.55) = 0.353 157 \le 1.0$

#### Note:

- Between WCDMA and LTE, WCDMA is chosen as worst case.
- WCDMA and LTE do not transmit simultaneously.
