

FOB-4F34 Fob Smart Key

Manual for vehicle manufacturer

OUTLINE

1. How to use FOB-4F34

- FOB-4F34 is a part of Remote Keyless System.
- This unit controls door lock/door unlock/remote engine start-stop/tailgate open/panic wirelessly.

2. Introduction of Transmitter (FOB-4F34)

- Transmitter has five buttons
- Transmitter use the battery
- Frequency is 433.92MHz

GENERAL DESCRIPTION

PRIMARY FUNCTION

- Remote door lock/door unlock/remote engine start-stop/tailgate open/panic wirelessly
- Operating voltage : 3V DC
- Center freq.: 433.92MHz

Manual

1) LOCK Button

If the LOCK button is pushed, then TRANSMITTER sends the LOCK Data.

2) UNLOCK Button

If the UNLOCK button pushed is, then TRANSMITTER sends the UNLOCK Data.

3) Panic Button

If the Panic button is pushed, then TRANSMITTER sends the Panic Data.

4) Tailgate Button

If the Tailgate button is pushed, then TRANSMITTER sends the Tailgate open Data.

5) Start-Stop Button

If the Start-Stop button is pushed, then TRANSMITTER sends the remote engine start-stop Data.

How to change the battery

- 1) Pull out the metal key from the fob.
- 2) Plug the key at the case edge and twist to open.
- 3) Place a new battery (button cell)

- FCC ID is located in battery compartment and user will be able to see the FCC ID when they change the battery.
