





#### 2.2.2.2. Momentarily Operated Devices

According to A.1 of RSS-210 Issue 10.

The operation of momentarily operated devices is permitted in the bands specified in tables A1 and A2 of this annex, but is prohibited in the restricted frequency bands listed in RSS-Gen.

The frequency bands and field strength limits in tables A1 and A2 are reserved exclusively for the transmission of a control signal, such as those used with alarm systems, door openers, remote switches, etc. Data may be sent with a control signal. Radio control of toys or model aircraft, as well as continuous transmissions (such as voice or video), are not permitted, except as provided in section A.1.4 below.

#### 2.3. Test Procedures

Radiated emissions from the EUT were measured according to the dictates of ANSI C63.10-2013.

#### 2.3.1. Test Procedures for emission below 30 Mb

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. Then antenna is a loop antenna is fixed at one meter above the ground to determine the maximum value of the field strength. Both parallel and perpendicular of the antenna are set to make the measurement.
- c. For each suspected emission, the EUT was arranged to its worst case and then the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- d. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.

#### 2.3.2. Test Procedures for emission from 30 Mb to 1 000 Mb

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. During performing radiated emission below 1 % the EUT was set 3 meters away from the interference receiving antenna, which was mounted on the top of a variable-height antenna tower. During performing radiated emission above 1 % the EUT was set 3 meter away from the interference-receiving antenna.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.

#### 2.3.3. Test Procedures for emission above 1 @

- a. The EUT was placed on the top of a rotating table 1.5 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1 Mb for Peak detection at frequency above 1 Gb.





#### 9th harmonic





# 3.1. Test Setup



#### 3.2. **Limit**

According to §15.231(c), the bandwidth of the emission shall be no wider than 0.25 % of the center frequency for devices operating above 70  $\,\mathrm{Mz}$  and below 900  $\,\mathrm{Mz}$ . For devices operating above 900  $\,\mathrm{Mz}$ , the emission shall be no wider than 0.5 % of the center frequency. Bandwidth is determined at the points 20  $\,\mathrm{dB}$  down from the modulated carrier.

#### 3.3. Test Procedure

- 1. The transmitter output is connected to the spectrum analyzer.
- 2. The resolution bandwidth (RBW) shall be in the range of 1 % to 5 % of the occupied bandwidth (OBW) and video bandwidth (VBW) shall be approximately 3 x RBW.
- 3. The bandwidth of fundamental frequency was measured and recorded.



#### - Test plot





#### 4.2. Limit

According to A.1.3 of RSS-210 Issue 10, the occupied bandwidth of momentarily operated devices shall be less than or equal to 0.25 % of the centre frequency for devices operating between 70  $\,\text{Mz}$  and 900  $\,\text{Mz}$ . For devices operating above 900  $\,\text{Mz}$ , the occupied bandwidth shall be less than or equal to 0.5 % of the centre frequency.





#### 5.2.1. FCC

#### 5.2.2. IC

According to A.1.1(a) of RSS-210 Issue 10, a manually operated transmitter shall be equipped with a push-to-operate switch and be under manual control at all times during transmission. When released, the transmitter shall cease transmission within no more than 5 seconds of being released.

#### 5.3. Test Procedure

- 1. The transmitter output is connected to the spectrum analyzer.
- 2. The bandwidth of the fundamental frequency was measured with the spectrum analyzer using RBW = 1 Mz, VBW = 1 Mz, Span = 0 Hz, Sweep Time = 10 sec.
- 3. The bandwidth of fundamental frequency was measured and recorded.






