4.3. Test Procedure

- 1. The RF output power was measured with a spectrum analyzer connected to the RF Antenna connector (conducted measurement) while EUT was operating in transmit mode at the appropriate center frequency, A spectrum analyzer was used to record the shape of the transmit signal.







6.2. Limit

Limit: ≥ 25 kHz or ≥ Two-Thirds of the 20 dB BW whichever is greater.

6.3. Test Procedure

The carrier frequency separation was measured with a spectrum analyzer connected to the antenna terminal, while EUT had its hopping function enabled.

After the trace being stable, the reading value between the peaks of the adjacent channels using the markerdelta function was recorded as the measurement results.






















Carrier Frequency Separation (AFH) <u>Hopping mode : Enable&π/4DQPSK</u>








Number of Hopping Channels 2(FH) <u>Hopping mode : Enable & GFSK</u>











Number of Hopping Channels 2(FH) <u>Hopping mode : Enable &π/4DQPSK</u>












Number of Hopping Channels 2(FH) <u>Hopping mode : Enable & 8DPSK</u>





9.2. Limit

Part 15.247(d), Part 15.205, Part 15.209

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of Part 15.247 the attenuation required under this paragraph shall be 30 dB instead of 20 dB. 9.3. Test Procedures

9.3.1. Test Procedures for Unwanted Emissions(Radiated)

- 1. The EUT is placed on a non-conductive table. For emission measurements at or below 1 GHz, the table height is 80 cm. For emission measurements above 1 GHz, the table height is 1.5 m. The table was rotated 360 degrees to determine the position of the highest radiation.
- 2. During performing radiated emission below 1 GHz, the EUT was set 3 meters away from the interference receiving antenna, which was mounted on the top of a variable-height antenna tower. During performing radiated emission above 1 GHz, the EUT was set 1 or 3 meter away from the interference-receiving antenna.
- 3. For measurements above 1 GHz absorbers are placed on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections. For measurements below 1 GHz, the absorbers are removed.
- 4. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- 5. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- 6. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode
- 7. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

Measurement Instrument Setting

- Frequencies less than or equal to 1 000 MHz The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120 kHz for Quasipeak detection (QP) at frequency below 1 GHz.
- Frequencies above 1 000 MHz The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1 MHz for Peak detection and frequency above 1 GHz. The result of Average measurement is calculated using PK result and duty correction factor.

9.3.2. Test Procedures for Unwanted Emissions(Conducted)

- 1. The transmitter output was connected to the spectrum analyzer.
- 2. The reference level of the fundamental frequency was measured with the spectrum analyzer using RBW = 100 kHz, VBW = 300 kHz.
- 3. The conducted spurious emission was tested each ranges were set as below.

Frequency range: 9 kHz ~ 30 MHz

RBW = 100 kHz, VBW = 300 kHz, SWEEP TIME = AUTO, DETECTOR = PEAK, TRACE = MAX HOLD, SWEEP POINT : 40 001

Frequency range: 30 MHz ~ 10 GHz, 10 GHz ~ 25 GHz

RBW = 1 MHz, VBW = 3 MHz, SWEEP TIME = AUTO, DETECTOR = PEAK, TRACE = MAX HOLD, SWEEP POINT : 40 001

If the emission level with above setting was close to the limit (ie, less than 3 dB margin) then zoom scan is required using RBW = 100 kHz, VBW = 300 kHz, SPAN = 100 MHz and BINS = 2 001 to get accurate emission level within 100 kHz BW.

9.4. Test Results

9.4.1. Unwanted Emissions(Radiated)

- 1. The radiated emissions were investigated 9 kHz to 25 GHz. And no other spurious and harmonic emissions were found below listed frequencies.

10.2. Limit

According to §15.207(a) for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 kHz to 30 MHz, shall not exceed the limits in the following table, as measured using a 50 uH/50 ohm line impedance stabilization network (LISN).

Compliance with the provision of this paragraph shall on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower applies at the boundary between the frequency ranges.

10.3. Test Procedure

Conducted emissions from the EUT were measured according to the ANSI C63.10.

- 1. The test procedure is performed in a $6.5 \text{ m} \times 3.5 \text{ m} \times 3.5 \text{ m} (L \times W \times H)$ shielded room. The EUT along with its peripherals were placed on a $1.0 \text{ m} (W) \times 1.5 \text{ m} (L)$ and 0.8 m in height wooden table and the EUT was adjusted to maintain a 0.4 meter space from a vertical reference plane.
- 2. The EUT was connected to power mains through a line impedance stabilization network (LISN) which provides 50 ohm coupling impedance for measuring instrument and the chassis ground was bounded to the horizontal ground plane of shielded room.
- 3. All peripherals were connected to the second LISN and the chassis ground also bounded to the horizontal ground plane of shielded room.
- 4. The excess power cable between the EUT and the LISN was bundled. The power cables of peripherals were unbundled. All connecting cables of EUT and peripherals were moved to find the maximum emission.
