3.2 Transmitter requirements

3.2.1 Carrier Frequency Separation

Procedure:

The carrier frequency separation was measured with a spectrum analyzer connected to the antenna terminal, while EUT had its hopping function enabled.

After the trace being stable, the reading value between the peaks of the adjacent channels using the marker-delta function was recorded as the measurement results.

The spectrum analyzer is set to:

Span = 3 MHz (wide enough to capture the peaks of two adjacent channels)

RBW = 30 kHz (1% of the span or more) Sweep = auto

VBW = 30 kHz Detector function = peak





Figure 1: Measurement setup for the carrier frequency separation

3.2.2 Number of Hopping Frequencies

Procedure:

The number of hopping frequencies was measured with a spectrum analyzer connected to the antenna terminal, while EUT had its hopping function enabled.

To get higher resolution, four frequency ranges within the 2400 ~ 2483.5 MHz FH band were examined.

The spectrum analyzer is set to:

Frequency range 1: Start = 2389.5MHz, Stop = 2414.5 MHz

2: Start = 2414.5MHz, Stop = 2439.5 MHz

3: Start = 2439.5MHz, Stop = 2464.5 MHz


Number of Hopping Frequencies

3.2.3 20 dB Bandwidth

Procedure:

The bandwidth at 20 dB below the highest inband spectral density was measured with a spectrum analyzer connected to the antenna terminal, while EUT had its hopping function disabled at the highest, middle and the lowest available channels...

After the trace being stable, Use the marker-to-peak function to set the marker to the peak of the emission. Use the marker-delta function to measure 20dB down one side of the emission. Reset the marker-delta function, and move the marker to the other side of the emission, until it is (as close as possible to) even with the reference marker level. The marker-delta reading at this point is the 20 dB bandwidth of the emission.

The spectrum analyzer is set to:

Center frequency = the highest, middle and the lowest channels

Span = 2 MHz (approximately 2 or 3 times of the 20 dB bandwidth)

RBW = 30 kHz Sweep = auto

 $VBW = 30 \text{ kHz} (VBW \ge RBW)$ Detector function = peak

3.2.5 Transmitter Output Power

Procedure:

The peak output power was measured with a spectrum analyzer connected to the antenna terminal, while EUT had its hopping function disabled at the highest, middle and the lowest available channels..

After the trace being stable, Use the marker-to-peak function to set the marker to the peak of the emission. The indicated level is the peak output power.

The spectrum analyzer is set to:

Center frequency = the highest, middle and the lowest channels

Span = 3 MHz (approximately 5 times of the 20 dB bandwidth)

RBW = 1 MHz (greater than the 20dB bandwidth of the emission being measured)







3.2.6 Band Edge

Procedure:

The bandwidth at 20dB down from the highest inband spectral density is measured with a spectrum analyzer connected to the antenna terminal, while EUT had its hopping function disabled at the highest, middle and the lowest available channels.

After the trace being stable, Use the marker-to-peak function to measure 20 dB down both sides of the intentional emission.

The spectrum analyzer is set to:

Center frequency = the highest, middle and the lowest channels

RBW = 100 kHz VBW = 100 kHz

Span = 10 MHz Detector function = peak

Trace = \max hold Sweep = auto





3.2.7 Field Strength of Harmonics

Procedure:

The EUT was placed on a 0.8m high wooden table inside a shielded enclosure. An antenna was placed near the EUT and measurements of frequencies and amplitudes of field strengths were recorded for reference during final measurements. For final radiated testing, measurements were performed in OATS. Measurements were performed with the EUT oriented in 3 orthogonal axis and rotated 360 degrees to determine worst-case orientation for maximum emissions.

Center frequency = the worst channel

Frequency Range = 30 MHz ~ 10th harmonic.



3.2.8 AC Conducted Emissions

Procedure:

The conducted emissions are measured in the shielded room with a spectrum analyzer in peak hold. While the measurement, EUT had its hopping function disabled at the middle channels in line with Section 15.31(m). Emissions closest to the limit are measured in the quasi-peak mode (QP) with the tuned receiver using a bandwidth of 9 kHz. The emissions are maximized further by cable manipulation and Exerciser operation. The highest emissions relative to the limit are listed.




