#### 2.2 DESCRIPTION OF THE TEST MODES

To investigate the maximum EMI emission characteristics generates from EUT, the test system was pre-scanning tested base on the consideration of following EUT operation mode or test configuration mode which possible have effect on EMI emission level. #### 2.3 FREQUENCY HOPPING SYSTEM REQUIREMENTS

#### (1)Standard and Limit

According to FCC Part 15.247(a)(1)&RSS 247 Section 5.1, The system shall hop to channel frequencies that are selected at the system hopping rate from a pseudo randomly ordered list of hopping frequencies. Each frequency must be used equally on the average by each transmitter. The system receivers shall have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shall shift frequencies in synchronization with the transmitted signals.

Frequency hopping spread spectrum systems are not required to employ all available hopping channels during each transmission. However, the system, consisting of both the transmitter and the receiver, must be designed to comply with all of the regulations in this section should the transmitter be presented with a continuous data (or information) stream. In addition, a system employing short transmission bursts must comply with the definition of a frequency hopping system and must distribute its transmissions over the minimum number of hopping channels specified in this section.




The incorporation of intelligence within a frequency hopping spread spectrum system that permits the system to recognize other users within the spectrum band so that it individually and independently chooses and adapts its hop sets to avoid hopping on occupied channels is permitted. The coordination of frequency hopping systems in any other manner for the express purpose of avoiding the simultaneous occupancy of individual hopping frequencies by multiple transmitters is not permitted.

(2)The Pseudorandom sequence may be generated in a nin-stage shift register whose 5<sup>th</sup> and 9<sup>th</sup> stage outputs are added in a modulo-two addition stage. And the result is fed back to the input of the first stage. The sequence begins with the first one of 9 consecutive ones: i.e. the shift register is initialized with nine ones.



Each frequency used equally on th average by each transmitter.

The system receivers have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shift frequencies ini synchronization with the transmitted signals.

#### (3)Frequency Hopping System

This transmitter device is frequency hopping device, and complies with FCC part 15.247 rule.

This device uses Bluetooth radio which operates in 2400-2483.5 MHz band. Bluetooth uses a radio technology called frequency-hopping spread spectrum, which chops up the data being sent and transmits chunks of it on up to 79 bands (1 MHz each; centred from 2402 to 2480 MHz) in the range 2,400-2,483.5MHz. The transmitter switches hop frequencies 1,600 times per second to assure a high degree of data security. All Bluetooth devices participating in a given piconet are synchronized to the frequency-hopping channel for the piconet. The frequency hopping sequence is determined by the master's device address and the phase of the hopping sequence (the frequency to hop at a specific time) is determined by the master's internal clock. Therefore, all slaves in a piconet must know the master's device address and must synchronize their clocks with the master's clock.

Adaptive Frequency Hopping (AFH) was introduced in the Bluetooth specification to provide an effective way for a Bluetooth radio to counteract normal interference. AFH identifies "bad" channels, where either other wireless devices are interfering with the Bluetooth signal or the Bluetooth signal is interfering with another device. The AFH-enabled Bluetooth device will then communicate with other devices within its piconet to share details of any identified bad channels. The devices will then switch to alternative available "good" channels, away from the areas of interference, thus having no impact on the bandwidth used.

This device was tested with a bluetooth system receiver to check that the device maintained hopping synchronization, and the device complied with these requirements FCC Part 15.247 rule.



#### 2.4 TABLE OF PARAMETERS OF TEST SOFTWARE SETTING

During testing channel & power controlling software provided by the customer was used to control the operating channel as well as the output power level. The RF output power selection is for the setting of RF output power expected by the customer and is going to be fixed on the firmware of the final end product power parameters of FHSS.



#### 3.1 CONDUCTED EMISSION MEASUREMENT

#### 3.1.1 POWER LINE CONDUCTED EMISSION LIMITS

The radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 kHz to 30 MHz, shall not exceed the limits in the following table.



#### 3.1.2 TEST PROCEDURE

- a. The EUT is 0.8 m from the horizontal ground plane and 0.4 m from the vertical ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipments are powered from additional LISN(s). The LISN provides 50 Ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 to 40 cm long.
- c. I/O cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.
- d. LISN is at least 80 cm from the nearest part of EUT chassis.
- e. For the actual test configuration, please refer to the related Item –EUT Test Photos.

#### 3.1.3 TEST SETUP



Note: 1. Support units were connected to second LISN.

Both of LISNs (AMN) are 80 cm from EUT and at least 80 cm from other units and other metal planes support units.

#### 3.1.4 EUT OPERATING CONDITIONS

The EUT was configured for testing in a typical fashion (as a customer would normally use it). The EUT has been programmed to continuously transmit during test. This operating condition was tested and used to collect the included data.







#### 3.2.2 TEST PROCEDURE

- a. The measuring distance at 3 m shall be used for measurements at frequency 0.009MHz up to 1GHz, and above 1GHz.
- b. The EUT was placed on the top of a rotating table 0.8 m (above 1GHz is 1.5 m) above the ground at a 3 m anechoic chamber test site. The table was rotated 360 degree to determine the position of the highest radiation.






# (A) Radiated Emission Test-Up Frequency Below 30MHz

## 4. CONDUCTED SPURIOUS & BAND EDGE EMISSION

#### 4.1 LIMIT

According to FCC section 15.247(d)&RSS-247 Issue 2, February 2017 (5.5), in any 100kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement.

#### 7. HOPPING CHANNEL SEPARATION MEASUREMEN

#### **7.1 LIMIT**

Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW.

#### 9.2 TEST PROCEDURE

This is an RF-conducted test to evaluate maximum peak output power. Use a direct connection between the antenna port of the unlicensed wireless device and the spectrum analyzer, through suitable attenuation. The hopping shall be disabled for this test:

- a) Use the following spectrum analyzer settings:
- 1) Span: Approximately five times the 20 dB bandwidth, centered on a hopping channel.

### 10. ANTENNA REQUIREMENT

# 10.1 STANDARD REQUIREMENT

15.203&RSS-Gen Issue 5 requirement: For intentional device, according to 15.203&RSS-Gen Issue 5: an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

# 10.2 EUT ANTENNA

#### 11. FREQUENCY STABILITY

# 11.1 LIMITS OF FREQUENCY STABILITY MEASUREMENT

The frequency tolerance of the carrier signal shall be maintained within +/-0.02% of the operating frequency over a temperature variation of -30 degrees to 50 degrees C at normal supply voltage, and for a variation in primary supply voltage from 85% to 115% of the rated supply voltage at a temperature of 20 degrees.

### 11.2 TEST PROCEDURE

- 1. The EUT was placed inside the environmental test chamber and powered by nominal DC voltage.
- 2. Turn the EUT on and couple its output to spectrum analyzer.
- 3. Turn the EUT off and set the chamber to the highest temperature specified.
- 4. Allow sufficient time (approximately 30 min) for the temperature of the chamber to stabilize, turn the EUT on and measure the operating frequency after 2,5, and 10 minutes.
- 5. Repeat step 2 and 3 with the temperature chamber set to the lowest temperature.
- 6. The test chamber was allowed to stabilize at +20 degree C for a minimum of 30 minutes. The supply voltage was then adjusted on the EUT from 85% to 115% and the frequency record.
