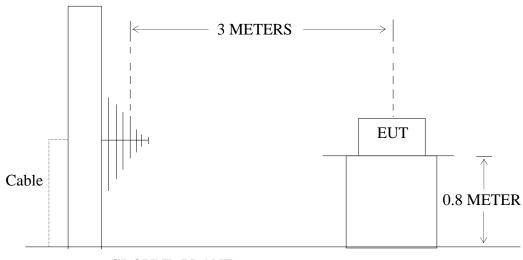
4.1.1.Block diagram of connection between the EUT and simulators

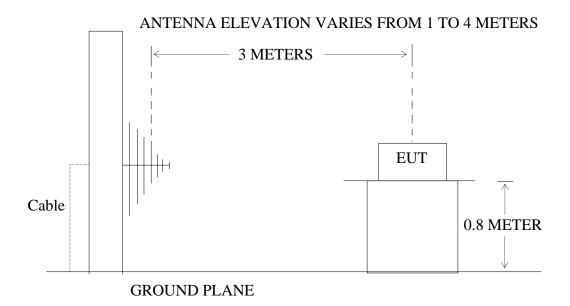

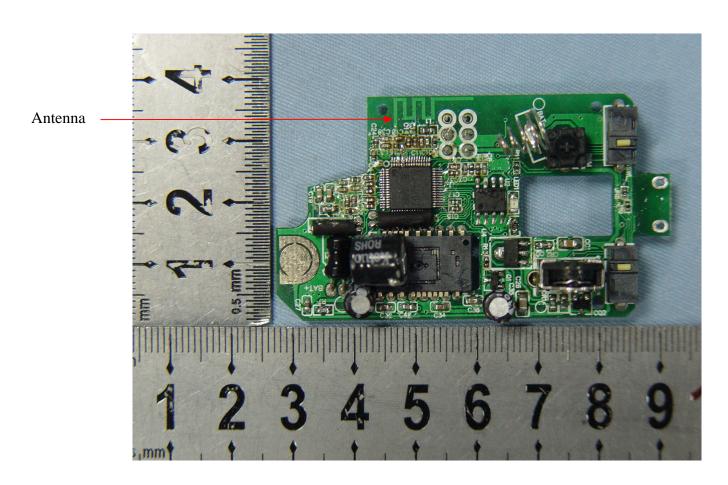
# 7. ANTENNA REQUIREMENT
