

8.3 Test Procedure

- 1) Check the calibration of the measuring instrument (spectrum analyzer) using either an internal calibrator or a known signal from an external generator.
- 2) Set the spectrum analyzer as follows: Span = approximately 5 times the 20 dB bandwidth, centred on a hopping channel; RBW > the 20 dB bandwidth of the emission being measured; VBW ≥ RBW; Sweep =auto; Detector function = peak; Trace = max hold

3) Measure the highest amplitude appearing on spectral display and record the level to calculate results.

4) Repeat above procedures until all frequencies measured were complete.

8.4 Limits

According to \$15.247(b)(1), for frequency hopping systems operating in the 2400-2483.5 MHz band employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5725-5850 MHz band: 1 watt. For all other frequency hopping systems in the 2400-2483.5MHz band: 0.125 watts. According to \$15.247(b)(4), the conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.







2. Measure the separation between the peaks of the adjacent channels using the marker-delta function.

3. Repeat above procedures until all frequencies measured were complete.

According to §15.247(a)(1), frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW.





Modulation: GFSK Low channel








Modulation Type: GFSK Packet Type: DH1






- 13.1.1 Test Method and test Procedure:
 - 1) The EUT was tested according to ANSI C63.10 –2009 and ANSI C63.4-2003.
 - 2) The EUT, peripherals were put on the turntable which table size is 1m x 1.5 m, table high 0.8 m. All set up is according to ANSI C63.10-2009 and ANSI C63.4-2003.
 - 3) The frequency spectrum from 9 kHz to 25 GHz was investigated. All readings from 9 kHz to 30 MHz are quasi-peak values with a resolution bandwidth of 9 kHz. All readings from 30 MHz to1 GHz are quasi-peak values with a resolution bandwidth of 120 kHz. All readings are above 1 GHz, peak values with a resolution bandwidth of 1 MHz. Measurements were made at 3 meters.
 - 4) The antenna high is varied from 1 m to 4 m high to find the maximum emission for each frequency.
 - 5) The antenna polarization: Vertical polarization and Horizontal polarization.








Block diagram of Test setup for frequency below 30MHz






14.0 Antenna Requirement

14.1 Standard Applicable

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC 47 CFR Section 15.247 (b), if transmitter antennas of directional gain greater than 6 dBi are used, the power shall be reduced by the mount in dB that the directional gain of the antenna exceeds 6 dBi.

14.2 Antenna Specification

According to the manufacturer declared, the EUT has a PCB antenna; the directional gain of antenna is 1.87 dBi, and no consideration of replacement. Therefore the EUT is considered sufficient to comply with the provision.
