
Installation


MPORTANT: Supported only from FortiWLC Release 8.4.0 or later and FortiGate with FortiOS Release

and later.

To attach the unit to a wall using the wall mount bracket:


- Using the wall-mount base as a template, mark the location of the mounting bolt holes on a flat wall surface. Drill the mounting holes in the marked locations and hammer the bolts into the openings.
- Place the lock and fat washer on the round head screws and drive the screws to attach mounting base to the back of the Access Point.
- Attach the device onto the wall by tightening the bolts fat washers and nuts to secure the mounting base to the mounting surface.







To attach the unit to a pole vertically or horizontally using the pole mount straps.

- 1. Place the lock and fat washer on the cap screws and drive the screws to attach the mounting base to the back of the Access Point.
- 2. Use the suitable sides of the pole mount bracket to mount AP on the pole.
- 3. Determine which mounting, vertical or horizontal to be assembled. Drive the four round head screws to attach the Pole Mount Bracket to the mounting base.
- 4. Thread the pole straps to the bracket for vertical or horizontal mounting.







Antennas

The FortiAP unit provides dual concurrent radio signals. Use the 2.4GHz antennas to access 2.4GHz radio (IEEE 802.11b/g/n) signals and the 5GHz antennas to access 5GHz radio (IEEE 802.11a/n/ac) signals. To use both radio frequencies concurrently, use all eight WiFi antennas.

Installing the WiFi Antennas

- 1. Insert the antenna base firmly into the appropriate antenna mount.
- 2. Securely hand tighten the fastening collar
- 3. Repeat for the remaining antennas



Connecting

Using the provided mounting hardware, attach the FortiAP unit to the wall or ceiling.

Adequate grounding must be provided to the FortiAP unit in compliance with the local electrical code.

This device complies with the IEEE 802.3at PoE specifications. Supports 4x4 MIMO and a default TX power of +24dBm in 2.4GHz channels and +23dBm in 5.0GHz channels.

Caution: This device complies with IEEE 802.3at PoE specification. Do not use any PoE injectors that are not IEEE 802.3at compliant, as they may damage your device.

To connect the FortiAP unit:

- Insert an Ethernet cable into the LAN1 or LAN2 port of the FortiAP unit.
- 2. Insert the other end of the Ethernet cable into your switch. The power LED will light up.

Supported Controller Types

FAP-U422EV is compatible with FortiWLC enterprise wireless LAN controllers, integrated FortiGate enterprise firewall LAN controllers, and FortiCloud controllers.

The FortiAP boots up with the FortiWLC AP image (factory default) and tries to discover the supported controllers. The FortiAP connects to the controller that is first discovered. If the FortiGate or the Forti Cloud controller is found, the FortiAP reboots with the FortiAP image.

To bring the FAP-U422EV back to factory default setting, run the reload default factory command on the FortiAP image.

Zero Configuration

The FortiAP unit is designed to require no configuration in most networks. Zero configuration mode works if the unit is directly connected to a Wireless LAN Controller (WLC) or is on the same layer-2 network and subnet as the FortiWLC, or if the unit is directly connected to the FortiGate LAN Controller or is on the same layer-3 network and subnet as the FortiGate or FortiCloud controller.

If the FortiAP wireless controller's IP address cannot be determined using Zero Configuration mode, or if the network uses static IP addresses, it can be configured to use a static IP address.

Zero Configuration

To enable the FortiAP using Zero Configuration:

- After connecting the FortiAP unit as described in the previous chapter, the unit goes through its boot procedure and requests an IP address from the DHCP server.
- 2. If the IP address is retrieved successfully, the FortiAP enters discovery mode to locate a Controller.

Zero Configuration

The discovery modes for FortiCloud controller are:

- Auto
- FortiCloud
- Verify that the FortiAP has successfully connected to the controller in the FortiWLC/FortiCloud/FortiGate WebUI.

Manual IP Configuration & Controller Discovery

To enable the FortiAP with a static IP address:

- 1. Connect the FortiAP device to a seperate private switch or hub.
- 2. Access the AP console through the serial port.
- To configure FortiAP's own IP address, type ip config net static address < ip-address> netmask < netmask ip-address> gateway < gateway ip-address>.
- 4. [FortiWLC only] To discover the controller, type **ip config 1213** <*12only* | *12preferred* | *13only* | *13preferred*>.
- To configure a designated wireless controller's IP address, type ip config controller name < controller ip-address>.
- 6. Save the configuration by typing **ip config save**.
- Unplug the FortiAP unit and plug it back in order for the configuration to take effect.
- Move the FortiAP to the intended deployment location and connect the Ethernet cable.
