### About FAP-U432F

IMPORTANT: Supported only from FortiWLC Release 8.6.2 or later and FortiGate with FortiOS Release 6.4.4 and later.

The FAP-U432F is a tri-radio, dual band 802.11ax 2.4/5GHz outdoor access point and supports three 4x4 MIMO radios. This high performance device complies with the 802.3bt, 802.3at, and 802.3af PoE specifications and supports BLE and ZigBee.

The FAP-U432F supports 11 external 5dBi 2.4/5GHz dual band omni antennas and operates with a default TX power of (To be updated) dBm in 2.4GHz channels and (To be updated) dBm in 5.0GHz channels.

The FAP-U432F is compatible with FortiWLC enterprise wireless LAN controllers, integrated FortiGate enterprise firewall LAN controllers, and FortiCloud controllers. This device can be wall mounted or pole mounted. Use the supplied hardware components to complete installing the unit.

### FAP-U432F Antennas

The FortiAP unit provides dual concurrent radio signals. Use the 2.4GHz antennas to access 2.4GHz radio (IEEE 802.11b/g/n) signals and the 5GHz antennas to access 5GHz radio (IEEE 802.11a/n/ac/ax) signals. To use both radio frequencies concurrently, use all 11 WiFi antennas. Follow this procedure to install the antennas.

- 1. Insert the antenna base firmly into the appropriate antenna mount.
- 2. Securely hand tighten the fastening collar
- 3. Repeat for the remaining antennas






# Wall Mounting FAP-U432F

Follow this procedure to attach the unit to a wall using the supplied equipment.

- Mark the location of the mounting bolt holes on a flat wall surface, using the wall-mount base as a template.
- 2. Drill mounting holes in the marked locations and hammer the bolts into the openings.
- 3. Attach the wall-mount base to the back of the access point using the mounting screws.




4. Attach the access point onto the wall using the mounting bolts and secure the mounting base to the wall.



# Pole Mounting FAP-U432F

Follow this procedure to attach the unit to a pole by using the supplied pole mount bracket, straps, and screws.

1. Attach the wall-mount bracket, then attach the pole-mount bracket using the mounting screws.




- 3. Loop the pole straps through the slots on the bracket, then around the pole.
- 4. Tighten the straps with screws to attach the unit securely to the pole.



# **Installing Weatherproof Connectors**


The weatherproof connects are provided for the LAN ports to ensure a watertight seal for connecting the Ethernet cable to the device.

 Unscrew the coupling ring from the waterproof connector, remove the sealing gland, and thread the RJ-45 plug through the connector components.



2. Insert the RJ-45 plug into the PoE port on the unit and install the weatherproof panel connector onto the threaded coupling at the port.

3. Slide the sealing gland along the cable into panel connector.



4. Thread the coupling ring onto the panel connector and tighten it until the sealing gland is compressed, making a watertight seal on the cable.






# Wall Mounting FAP-U234F

Follow this procedure to attach the unit to a wall using the supplied equipment.


- Mark the location of the mounting bolt holes on a flat wall surface, using the wall-mount base as a template.
- 2. Drill mounting holes in the marked locations and hammer the bolts into the openings.
- 3. Attach the wall-mount base to the back of the access point using the mounting screws.



# Pole Mounting FAP-U234F

Follow this procedure to attach the unit to a pole by using the supplied pole mount bracket, straps, and screws.


- 1. Attach the wall-mount bracket, then attach the pole-mount bracket using the mounting screws.
- 3. Loop the pole straps through the slots on the bracket and then around the pole.
- 4. Tighten the straps with screws to attach the unit securely to the pole.



# **Installing Weatherproof Connectors**


The weatherproof connects are provided for the LAN ports to ensure a watertight seal for connecting the Ethernet cable to the device.

 Unscrew the coupling ring from the waterproof connector, remove the sealing gland, and thread the RJ-45 plug through the connector components.



2. Insert the RJ-45 plug into the PoE port on the unit and install the weatherproof panel connector onto the threaded coupling at the port.

3. Slide the sealing gland along the cable into panel connector.



4. Thread the coupling ring onto the panel connector and tighten it until the sealing gland is compressed, making a watertight seal on the cable.




# Connecting FortiAP

Follow these steps to connect the FortiAP to your network.

- Connect one end of the ethernet cable to the LAN1 PoE+ port on the FortiAP. Connect the other end to the PoE port on the PoE adapter.
- Connect one end of the ethernet cable to the LAN port on the PoE adapter. Connect the other end to a switch.
- Connect one end of the console cable to the RJ-45 console port on the FortiAP. Connect the other end to a management computer for CLI access.
- Optionally, connect one end of the ethernet cable to the LAN2 PSE port. Connect the other end to an external device for power sourcing.
- 4. Plug the PoE adapter into an appropriate power outlet. The PWR LED will light up.

### NOTE:

The PIN060 and EPA5006GPR-4P POE Adapters are proprietary. Do not reverse the wires' connection, as this may damage the endpoint device.



# Controller Discovery

The FortiAP boots up with the default FortiWLC AP image and tries to discover the FortiWLC, FortiGate, and FortiCloud controllers simultaneously.

The FortiAP connects to the controller that is first discovered.

- If FortiWLC controller is discovered, the unit continues booting up with the default FortiWLC image.
- If the FortiGate or the FortiCloud controller is discovered, the unit reboots with the FortiAP image.

For the FortiAP to discover the FortiCloud controller, you need to add the unique FortiCloud key labelled on the device to the FortiCloud. See section *FortiCloud Deployment*.

For the FortiAP to complete the FortiGate discovery, you need to authorize the FortiAP on the FortiGate. See section *FortiGate Deployment*.


To bring the FortiAP back to factory default setting, insert a pin into the reset point on the power adapter and hold on for 10 seconds. Release the pin.

On the FortiAP image, run the *reload default factory* command to reset the FortiAP to factory default.

# FortiLAN Cloud Deployment

Follow these steps to complete the FortiLAN Cloud discovery.

- 1. Login into the FortiLAN Cloud GUI.
- Click Inventory > Import AP Key and enter the unique FortiLAN Cloud key located on your FortiAP device, then click Submit.




3. Deploy the FortiAP to an existing network, or create a new network, then click Submit.

- 4. Follow the prompts to associate the FortiAP device to an SSID.
- 5. Connect your FortiAP to an Internet connection. This can be a modem or another source of Internet connectivity.

Configure the discovered FortiAP.

# FortiGate Deployment

To complete the FortiGate controller discovery process, you need to authorize the FortiAP on the FortGate.



# Zero Configuration

The FortiAP unit is designed to require no configuration in most networks. Zero configuration mode works if the unit is on the same layer-2 network and subnet as the FortiWLC, or if the unit is on the same layer-3 network and subnet as the FortiGate or FortiCloud controller.

If the FortiAP wireless controller's IP address cannot be determined using Zero Configuration mode, or if the network uses static IP addresses, it can be configured to use a static IP address.

### To enable the FortiAP using Zero Configuration:

- 1. After connecting the FortiAP unit as described in the previous chapter, the unit goes through its boot procedure and requests an IP address from the DHCP server.
- If the IP address is retrieved successfully, the FortiAP enters discovery mode to locate a Controller.

The discovery modes for the FortWLC controller are:

- DHCP option 43
- DHCP option 138
- DNS
- Mesh PNP
- Static Controller IP address

### The discovery modes for FortiGate controller are:

- DHCP option 138
- DNS
- Multicast
- Broadcast
- Static Controller IP address

### The discovery mode for FortiCloud controller is:

- · FortiCloud Protocol
- 3. Verify that the FortiAP has successfully connected to the controller in the FortiWLC/FortiCloud/FortiGate WebUI.

# Manual IP Configuration and Controller Discovery

To enable the FortiAP with a static IP address:

- 1. Connect the FortiAP device to a seperate private switch or hub.
- 2. Access the AP console through the serial port.
- 3. To configure FortiAP's own IP address, type **ip config net static address** < *ip-address* > **netmask** < *netmask ip-address* > **gateway** < *gateway ip-address* > .
- [FortiWLC only] To discover the controller, type ip config 1213 < l2only | l2preferred | l3only | l3preferred>.
- To configure a designated wireless controller's IP address, type ip config controller name <controller ip-address>.
- 6. Save the configuration by typing ip config save.
- 7. Move the FortiAP to the intended deployment location and connect the Ethernet cable.

### Professional Installation Instructions

### 1. Installation personal

This product is designed for specific application and needs to be installed by a qualified personal who has RF and related rule knowledge. The general user shall not attempt to install or change the setting.

### 2. Installation location

The product shall be installed at a location where the radiating antenna can be kept FCC 39 cm and ISED 45 cm from nearby person in normal operation condition to meet Regulatory RF exposure requirement. The

installation applies to both indoor and outdoor location.

### For model FAP-U432F

The product shall be installed at a location where the radiating antenna can be kept 35 cm from nearby person in normal operation condition to meet regulatory RF exposure requirement.
