Setting up the charging cradle

The charging cradle is designed to be operated in enclosed, dry areas at temperatures ranging from +5°C to +45°C.

Place the charging cradle on a level, non-slip surface.

Pay attention to the range of the base station.
This is up to 300 m in unobstructed outdoor areas and up to 50 m inside buildings. The range is reduced when Eco Mode (\rightarrow page 1) is activated.


The phone's feet do not usually leave any marks on surfaces. However, due to the multitude of different varnishes and polishes used on today's furnishings, the occurrence of marks on the surfaces cannot be completely ruled out.

You can also mount the charging cradle on the wall.

Please note:

- Never expose the telephone to the influence of heat sources, direct sunlight or other electrical devices.
- Protect your Mitel from moisture, dust, corrosive liquids and vapours.

Connecting the charging cradle



- Connect the flat plug from the power supply 1.
- Plug the mains adapter into the plug socket 2.

If you need to disconnect the plug from the charging cradle, press the release button 1 and disconnect the plug 2.




The display is protected by a plastic film. Please remove the protective film!

Inserting the batteries and closing the battery cover

- Warning

Use only the rechargeable batteries (\rightarrow page 9) recommended by Gigaset Communications GmbH. Never use conventional (non-rechargeable) batteries, as this could result in significant health risks and damage to property. For example, the outer casing of the batteries could be destroyed or the batteries could explode. 
If you need to open the battery cover, for instance to replace the batteries, place your fingertip in the grooved area on the top of the cover and slide down.



Registering the handset to the base station

Before you can use the phone, you must first register the handset to the base station. The actual registration procedure will depend on the type of base station.

Automatically register the Mitel 5505H handset to the base station



Manually register the Mitel 5505H handset

You must activate manual registration of the handset **on both the handset and the base station**.

1. On the handset: MENU → Settings → OK → Handset → OK → Register HS

→ Enter the base station system PIN (default setting: 0000) → OK.



The registration screen is displayed.

2. On the base station: Within **60 seconds** of entering the system PIN, press and hold the registration/paging key (min. 3 seconds). See also the user guide for the base station.

After successful automatic or manual registration, the idle screen is displayed:



Charge status of the batteries:

- 🛈 🗇 🗇 🎟 (flat to full)
- 🗊 flashes: batteries almost flat

The handset is assigned the lowest unassigned internal number (1–4). If more than one handset is registered to the base station, the internal handset number appears in the top left of the display, e.g. 2. If the internal numbers 1–4 are already assigned to other devices, number 4 will be overwritten.

Please note

Only place the handset in the base station or charging cradle that is intended for it.

Initial charging and discharging of the batteries

The correct charge level can only be displayed if the batteries are first fully charged **and** discharged.



- Place the handset in the base station or charging cradle for eight hours.
 Then remove the handset from the base station or charging cradle and do not replace it until the batteries are fully discharged.
- Please note
- After the first battery charge and discharge you may replace your handset in the base station or charging cradle after every call.
- Always repeat the charging and discharging procedure if you remove the batteries from the handset and reinsert them.
- The batteries may warm up during charging. This is not dangerous.
- After a while, the charge capacity of the batteries will decrease for technical reasons.

Setting the date and time

Set the date and time so that the correct date and time can be assigned to incoming calls, and so that the alarm can be used.

Activating/deactivating the handset

Press and **hold** the end call key 🕤 to activate or deactivate the handset. If you place a deactivated handset in the base station or charging cradle, it will automatically activate.

Making calls

Making external calls and ending calls

External calls are calls using the public telephone network.

(Enter the phone number) + C.

The phone number is dialled. (Or you can **first** press and **hold** \checkmark [dial tone] and then enter the number.) During the call you can adjust the earpiece volume using (a) and set the volume with (a).

End the call/cancel dialling:

Press the end call key 🕤.

Accepting a call

The handset indicates an incoming call by ringing and by a display on the screen.

Press the talk key 🧨 to accept the call.

When **Auto Answer** is activated (see Menu tree, → page 16), simply remove the handset from the base station/charging cradle.

In idle status, use \uparrow to activate the menu for setting the call volume and use \downarrow to set the volume.

Switch to mute

You can mute your handset when making external calls. Your caller can no longer hear you. Press the "Microphone off" key 🛛 during the call to activate/deactivate the function.

Handsfree talking

To activate while dialling:

Enter the number 🚰 and press the handsfree key 🗹 .

Switching between earpiece and handsfree mode:

During a call and when listening to the answer machine, press the handsfree key \triangleleft to activate or deactivate handsfree talking.
