


TiVo USB WiFI 5 Adapter, 10" Extension Cable, Velcro



SETUP

STEP 1: Remove the cap from the USB adapter.

STEP 2: Insert the adapter into the USB slot on the back of your TiVo Mini VOX" or, for optimal performance, attach the extension cable to the USB adapter and plug the cord into the USB slot on your TiVo Mini VOX.



STEP 3: If using the extension cable, place the USB adapter on top of your TiVo Mini VOX. For best reception, position the adapter as close as possible to your Wi-Fi router. Use the Velcro to secure the adapter.



STEP 4: When prompted to choose a wireless network during setup, select the 5 GHz network (if available) for best performance.

TROUBLESHOOTING Having trouble connectir

- Try to access the Internet from other devices connected to your home net steps you routinely use to restore your home network connection.
- Go to the Network Settings screen and confirm that the correct wireless network name is displayed. If a 5 GHz network is available, be sure that it is the one being used. If necessary, select Change Network Settings to update your network information. 2
- Restart your router or cable modem by unplugging the power cord, waiting 10 seconds, then plugging it back in. 3.
- Restart the TiVo Mini VOX by unplugging it, waiting 10 seconds, and plugging it back in.
 Check for other possible sources of wireless interference. For example, wireless speakers operating in the 2.4 GHz or 5 GHz range can impact your connection.
