- 2 Pick up your Xfinity Voice Remote (handheld) and hold down the voice button to say: ***"Set up my hands-free remote."***

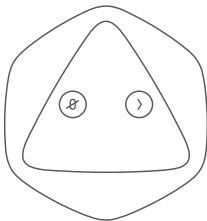

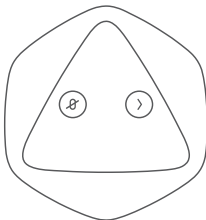
