

Wireless LM5053 Mouse

Quick Installation Guide

Hardware Installation

1. Turn the mouse upside down, then open their battery cover
2. Insert batteries, ensuring they are in the right type & direction.
3. Close their battery cover

ID Code Configuration

Your PC must be on to change the ID setting.

1. Press ID button on the side of the receiver once.
2. Press ID button on the bottom of the mouse once.

ID RESET KEY

This ID-recognition function helps to protect against interference from other RF mouse in the same environment. Remember to set the ID when you replace the batteries or your mouse kits do not work properly.

Important

1. Whenever you insert batteries, always make sure both of them are new.
Alkaline batteries are recommended.
2. Use the mouse on a clean, flat, non-slippery surface in order to ensure smooth and accurate cursor action.

Mouse power management:

1. Whenever you insert batteries or push the ID reset key on mouse, the power-on mode always starts on. & the " Sensor LED " light turns on.
2. Whenever you are continually pushing the ID reset key on mouse over 5 seconds, the power-off mode always starts on. & the " Sensor LED " light turns off.
