(1) Standalone SAR test exclusion for 100 MHz to 6 GHz at test separation distances ≤ 50mm

(Threshold_{1-g;10-g}) \times d_{seperation} / f ^{0.5}

where

Threshold_{1-q;10-q} is 3 for 1-g; 7.5 for 10-g

d_{seperation} is the min. test separation distance; 5mm is used if the distance is less

is the RF channel transmit frequency
