CONNECT TO THE IAP8350AG/IAP8351AG Access POINT


- 1. Attach and gently tighten the provided antennas to the appropriate port on the IAP8351AG
- 2. Power is provided through two Ethernet ports (LAN port). This is the preferred method of powering the AP on ceiling and wall installations
- 3. The IAP8350AG can also be powered by an external DC power supply plugged into an AC source. Plug the supply's input jack into the DC-In port

Tool-Less Ceiling Mount





