5. RF Exposure Evaluation

General Note:

- 1. This report is to evaluate the mobile exposure conditions, the test separation is 200 mm
- 2. The device support Wireless Power Consortium with a maximum power transfer to the client is 10W.
- 3. The RF Exposure was choose to test using a dummy load and a representative client device to found the worst-case results. And the battery state < 25% on a representative client device was used for testing

- 4. The equipment under test was placed on a desk. The isotropic field probe was used to measure the field strength for 6 EUT surfaces, and during measurement a separation of 20cm is maintained between client surface.
- 5. Per KDB 680106 D01, RF exposure evaluation field strengths anywhere at 20 cm surrounding the device from the source coils. Emissions between 100 kHz to 300 kHz should be assessed versus the limits at 300 kHz in Table 1 of Section 1.1310: 614 V/m and 1.63 A/m.
