

# **Key Instructions**

- Enrolling:
  - Refer to the Honeywell control unit installation manual.
  - Put the control panel in RF Learning mode.
    - May be Input Type "RF" for supervised operation. This must stay on site and can monitor "wandering user".
    - May be Input Type "UR" for unsupervised operation.
    - Press and release the button twice to enroll: causing the loop to fault... restore... (panel should beep to indicate ID capture)... fault... restore... [panel will confirm enrollment].
  - ...Or put the control panel in Serial Number entry mode
    - Enter as Loop 1.
    - Enter the Serial Number of the device (located on a label on the unit's back).
