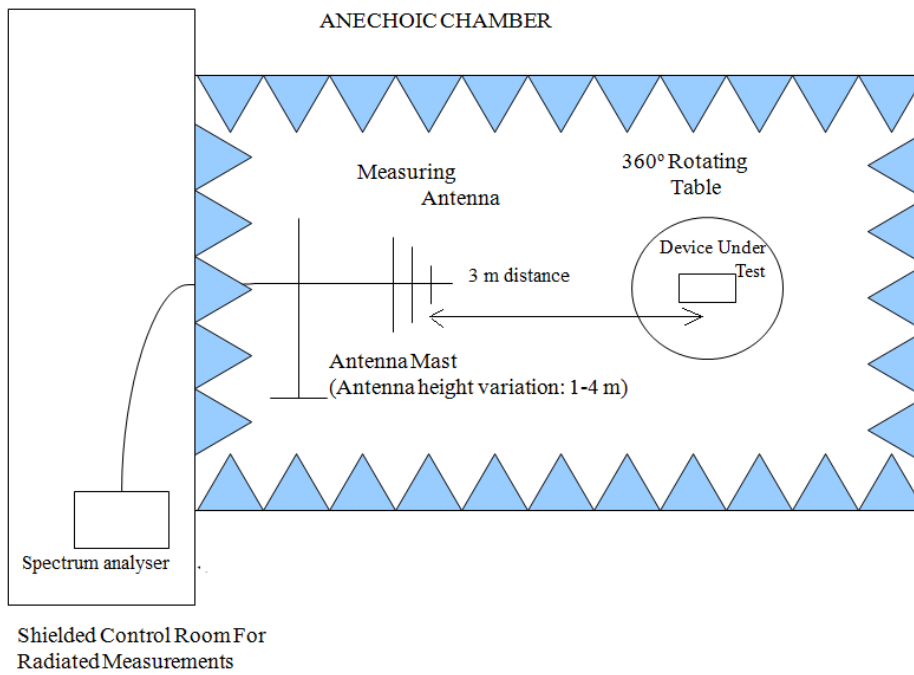

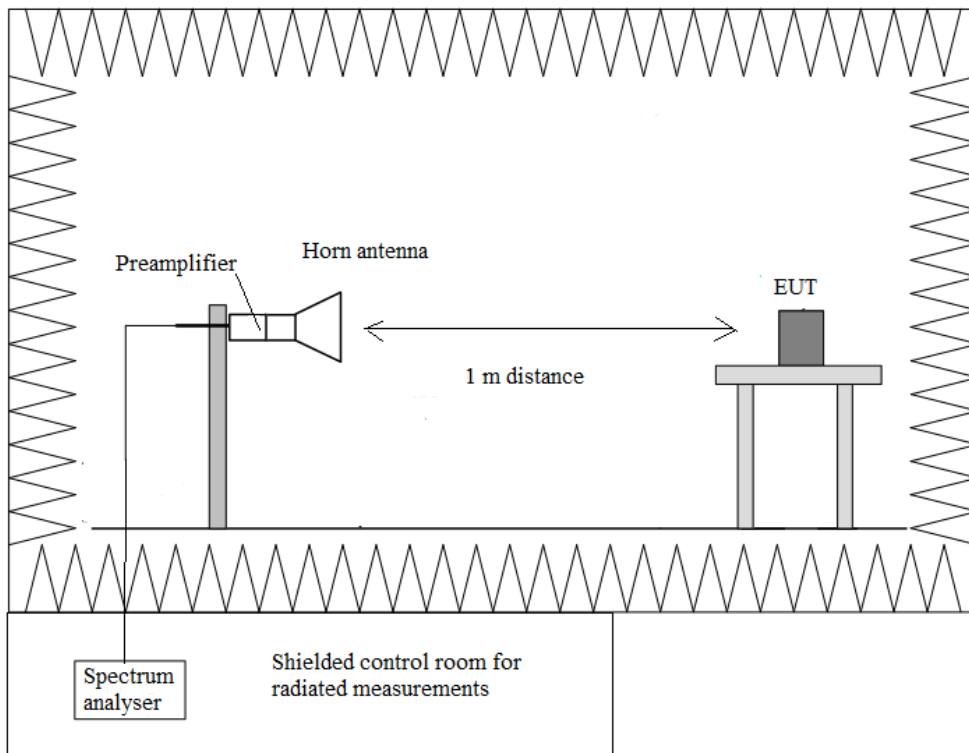

Radiated measurements setup $f > 1$ GHz



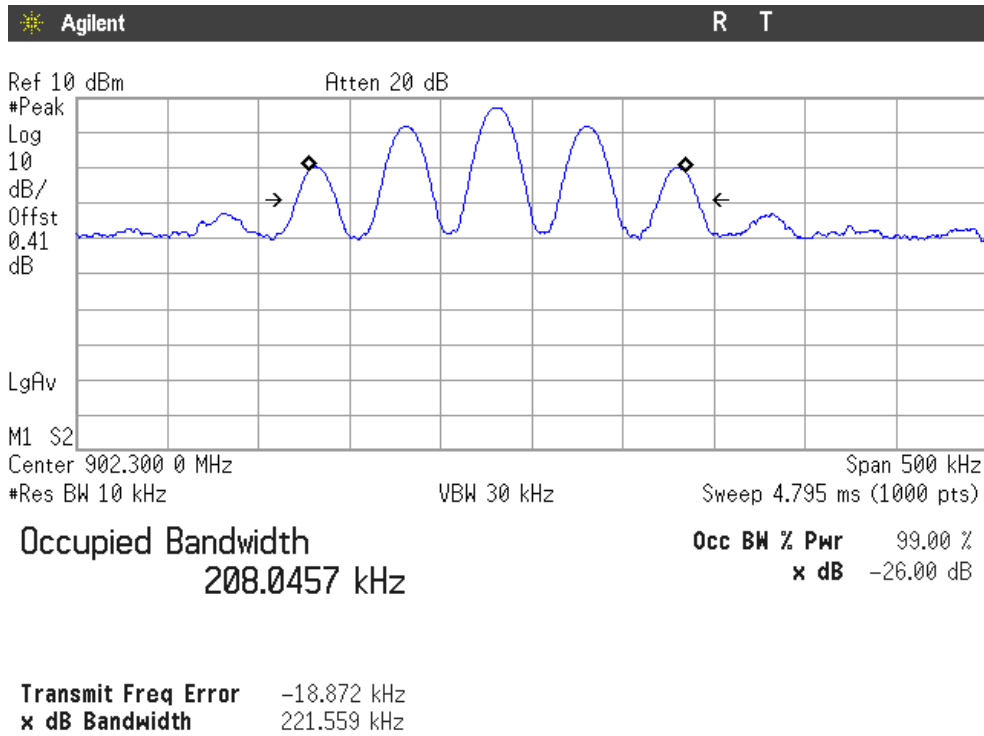

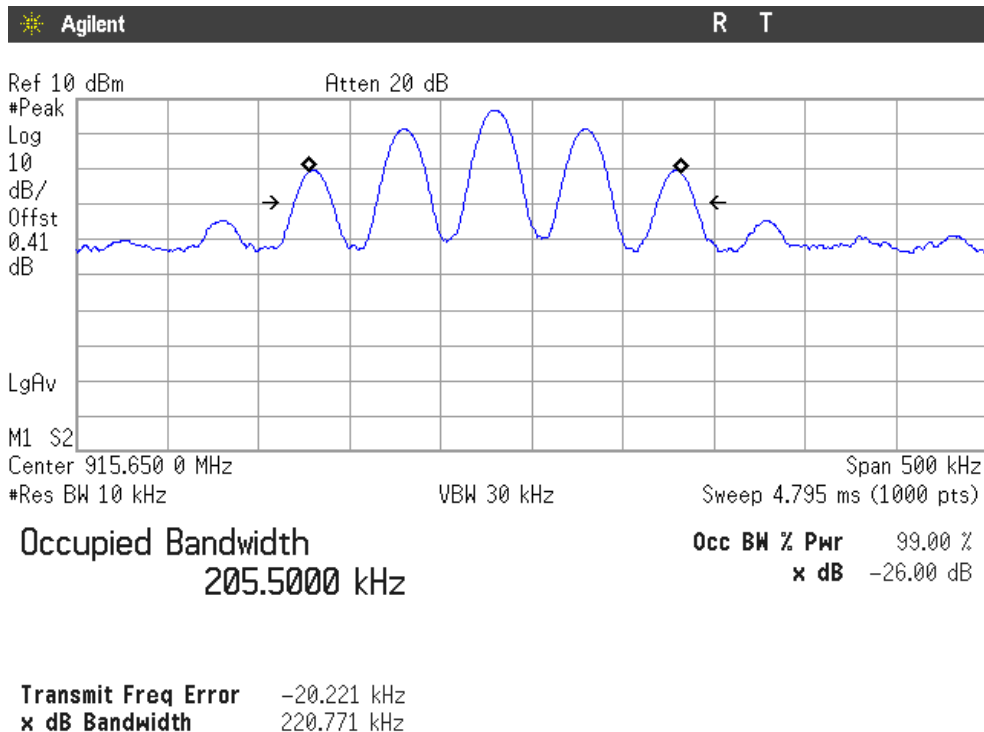

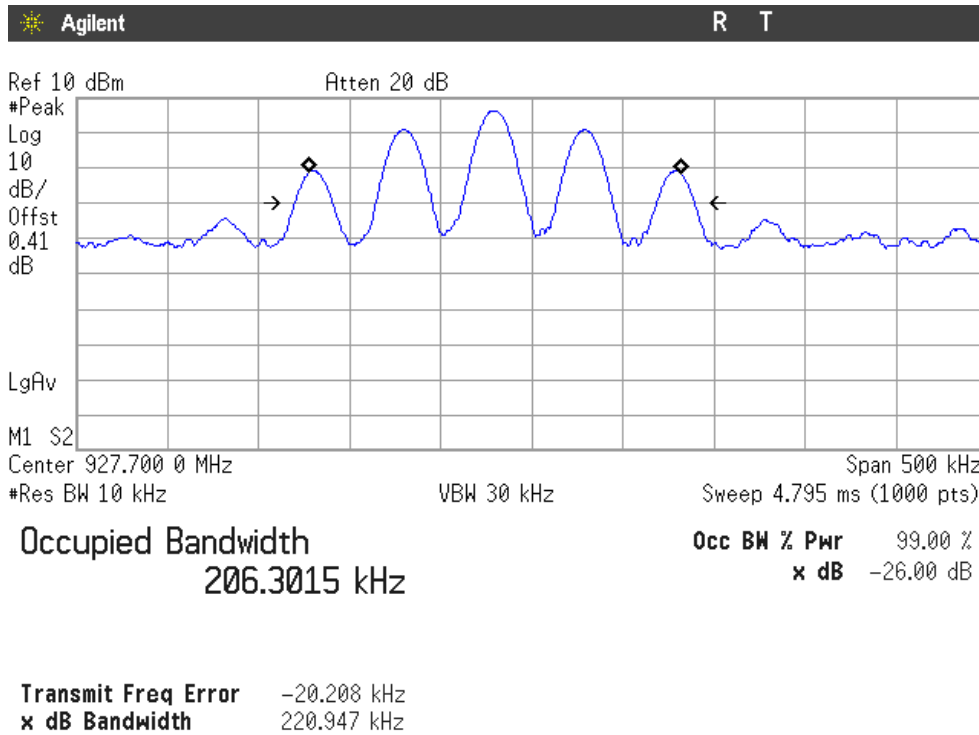

Middle Channel



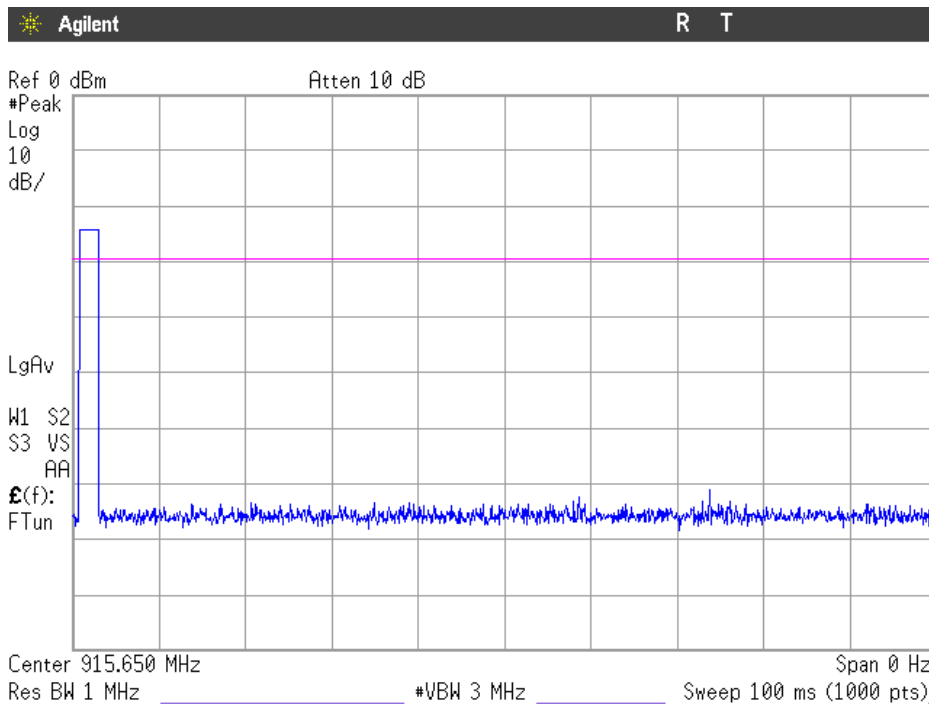

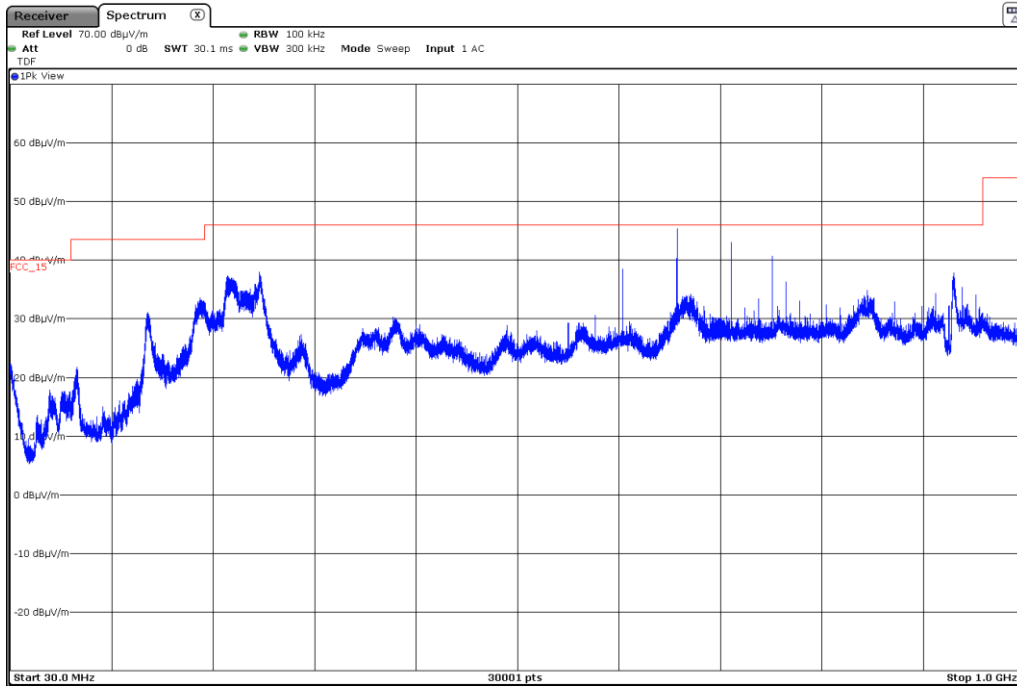

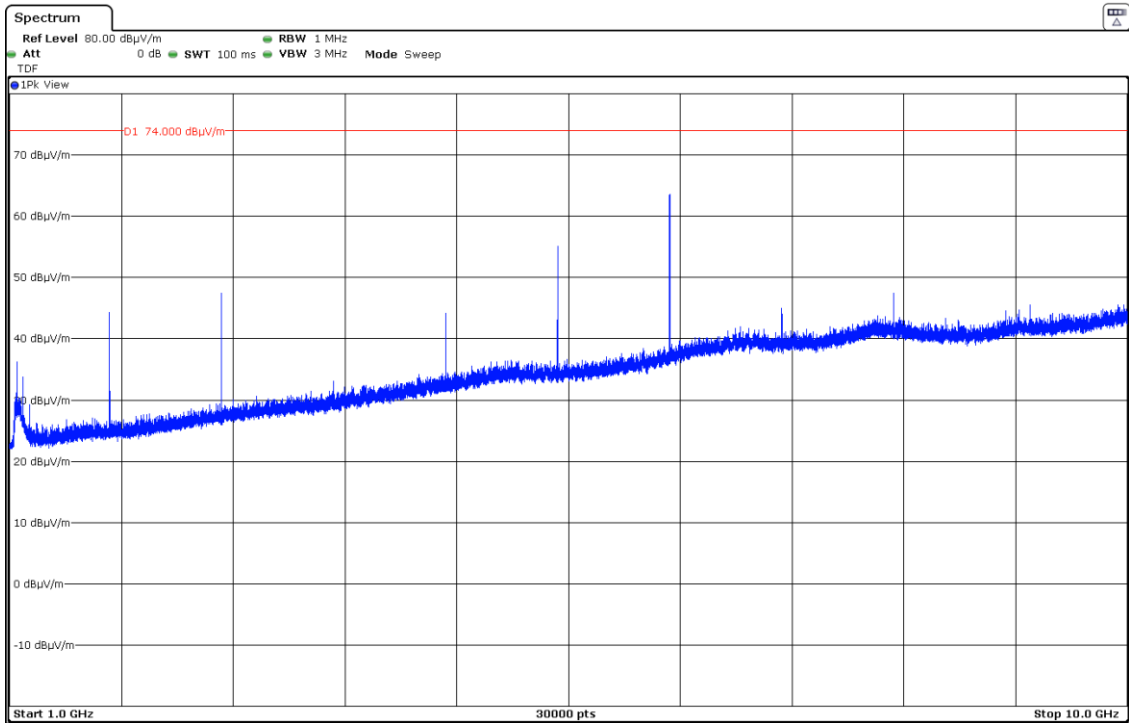

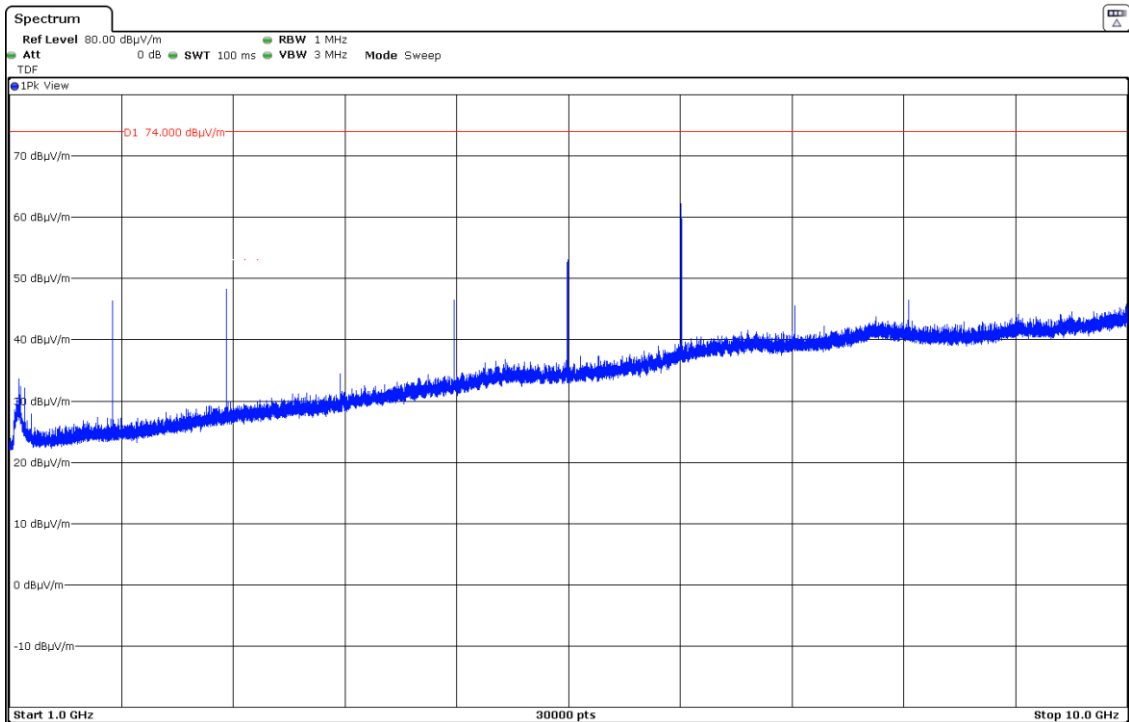
