Friis transmission formula: Pd = (Pout*G)/(4*Pi*R2)

Where

Pd = power density in mW/cm2

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

Pd id the limit of MPE, 1 mW/cm2. If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

exposure conditions for simultaneous transmission operations

Since the 2.4G Wifi and 5G Wifi use the same antennas, for MIMO mode, 2.4G Wifi and 5G Wifi can't tansmit simultaneously, the simultaneous transmission MPE is evaluated under SISO mode.

Simultaneous transmission MPE test is not required, because the Max. sum of the MPE ratios for WiFi 2.4G and WiFi 5G is 0.016+0.006=0.022 < 1
