

Test Procedure:

1) 9 kHz to 30 MHz emissions:

For testing performed with the loop antenna. The center of the loop was positioned 1 m above the ground and positioned with its plane vertical at the specied distance from the EUT.During testing the loop was rotated about its vertical axis for maximum response at each azimuth and also investigated with the loop positioned in the horizontal plane.

2) 30 MHz to 1 GHz emissions:

For testing performed with the bi-log type antenna. The measurement is performed with the EUT rotated 360^e, the antenna height scaned between 1m and 4m, and the antenna rotated to repeat the measurement for both the horizontal and vertical antenna polarizations.

3) 1 GHz to 40 GHz emissions:

Test site with RF absorbing material covering the ground plane that met the site validation criterion called out in CISPR 16-1-4:2010 was used to perform radiated emission test above 1 GHz.

For testing performed with the horn antenna. The measurement is performed with the EUT rotated 360^e, the antenna height scaned between 1m and 4m, and the antenna rotated to repeat the measurement for both the horizontal and vertical antenna polarizations.







2) Other Emissions:

The receive was scanned from the lowest frequency generated within the EUT to 5 GHz.When an emission was found, the table was rotated to produce the maximum signal strength. An initial pre-scan was performed for in peak detection mode using the receiver. The EUT was measured for both the Horizontal and Vertical polarities and performed a pre-test three orthogonal planes. The worst case emissions were reported.

An initial pre-scan was performed in the 3 m chamber using the spectrum analyzer in peak detection mode. Quasi-peak measurements were conducted based on the peak sweep graph. The EUT was measured by Bilog antenna with 2 orthogonal polarities.

The field strength is calculated by adding the Antenna Factor, Cable Factor & Peramplifier. The basic equation with a sample calculation is as follows:

Final Test Level = Receiver Reading + Antenna Factor + Cable Factor – Peramplifier Factor.




