




Fig.1 Photograph of the SAR measurement System




Fig. 2.1 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Left-head Side


Fig.2.2 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Right-head Side




Fig. 2.5 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)






Fig.5 Left Head Section/ Cheek-Touch Position






Fig.6 Left Head Section / Ear-Tilt Position(15°)




Fig. 7 Body worn- EUT front to flat phantom and distance between flat phantom and mobile phone is 1.5 cm




Fig.8 Body worn- EUT back to flat phantom and distance between flat phantom and mobile phone is 1.5 cm




Fig.17 AC Charger
