


#### 4.3 TEST PROCEDURES

- a. The EUT was placed 0.8 meters from the horizontal ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipments powered from additional LISN(s). The LISN provide 50 Ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 to 40 cm long.
- c. I/O cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.
- d. LISN at least 80 cm from nearest part of EUT chassis.




#### Bluetooth/1 Mbps/2402 MHz/10 Harmonic of the frequency




#### Bluetooth/3 Mbps/2441 MHz/10 Harmonic of the frequency

- a. The transmitter output (antenna port) was connected to the spectrum analyzer

- d. Sweep Time is more than once pulse time.
