THERE SHALL BE A BLANK SPACE ADDED AFTER EVERY FOURTH DIGIT OF THE HUMAN READABLE CHARACTERS, FOR EASIER READABILITY. **THE BAR CODE SHALL NOT CONTAIN THE SPACES.**

EXAMPLE: S/N: PPPP MMYJ JJSS SSSC AABB CCCC

5 THE HFC MAC ID ADDRESS: HUMAN READABLE CHARACTERS SHALL FOLLOW THE 'HFC MAC ID:' VERBIAGE, WITH A UNIFORM CHARACTER HEIGHT, AND THE BAR CODE SHALL BE PRINTED DIRECTLY UNDERNEATH THAT. THERE SHALL BE A BLANK SPACE ADDED AFTER EVERY SECOND DIGIT OF THE HUMAN READABLE CHARACTERS, FOR EASIER READABILITY. **THE BAR CODE SHALL NOT CONTAIN THE SPACES.**

EXAMPLE: HFC MAC ID: AB CD EF 01 23 45

6 THE GATEWAY MANAGEMENT MAC ID: HUMAN READABLE CHARACTERS SHALL FOLLOW THE 'GATEWAY MGMT MAC ID:' VERBIAGE, WITH A UNIFORM CHARACTER HEIGHT, AND THE BAR CODE SHALL BE PRINTED DIRECTLY UNDERNEATH THAT.

7 THE COUNTRY OF MANUFACTURE: SHALL INCLUDE THE NAME OF THE COUNTRY WHERE THE PRODUCT IS ASSEMBLED, FOLLOWING THE 'ASSEMBLED IN' VERBIAGE, WITH A UNIFORM CHARACTER HEIGHT.

8 THE FCI NUMBER: SHALL BE OBTAINED FROM THE CURRENT REVISION OF FINISHED GOOD DRAWING 595386, AND SHALL FOLLOW THE 'FCI:' VERBIAGE, WITH A UNIFORM CHARACTER HEIGHT. THE CORRECT FCI NUMBER IS DEFINED BY THE WHERE USED FINISHED GOOD ASSEMBLY.

9 THE SSID NUMBER: SHALL FOLLOW THE 'SSID-2.4:' VERBIAGE, WITH UNIFORM CHARACTER HEIGHT. TEXT CASE (UPPER OR LOWER) SHALL BE PRINTED EXACTLY AS IT APPEARS IN ASSOCIATED MIB VARIABLE.

10 THE WI-FI SECURITY KEY: SHALL BE PRINTED DIRECTLY UNDERNEATH THE LINE THAT READS 'WI-FI SECURITY KEY:', WITH UNIFORM CHARACTER HEIGHT. TEXT CASE (UPPER OR LOWER) SHALL BE PRINTED EXACTLY AS IT APPEARS IN ASSOCIATED MIB VARIABLE.

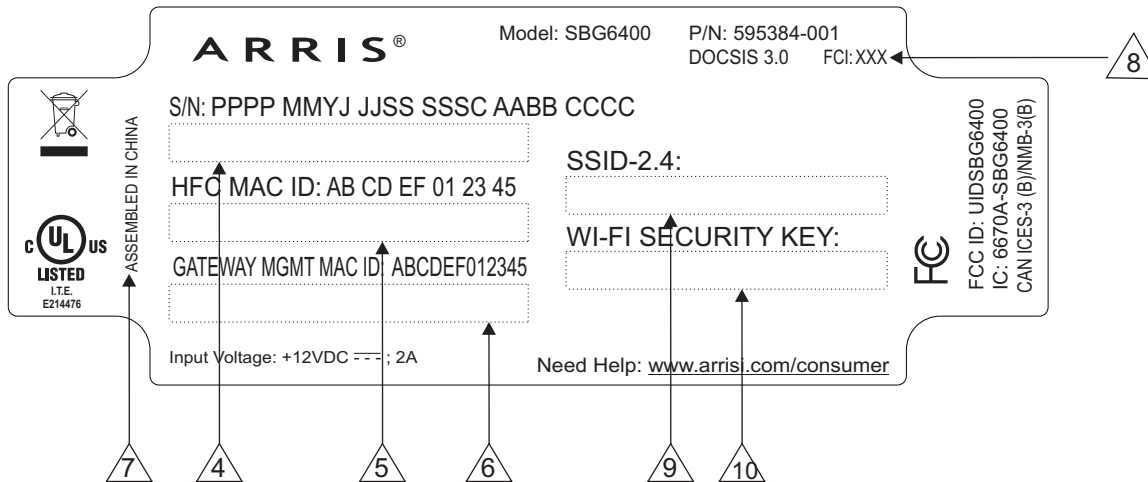
