


Figure 1. Block Diagram of Test Configuration

The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. § 15. 403(i) 26dB Bandwidth

Test Requirements: § 15.403(i): For purposes of this subpart the emission bandwidth shall be determined by measuring the width of the signal between two points, one below the carrier center frequency and one above the carrier center frequency, that are 26 dB down relative to the maximum level of the modulated carrier. Determination of the emissions bandwidth is based on the use of measurement instrumentation employing a peak detector function with an instrument resolution bandwidth approximately equal to 1.0 percent of the emission bandwidth of the device under measurement.

Test Procedure: The 26dB bandwidth was measured according to KDB789033 v01r03 Procedure C The EUT was connected to the spectrum analyzer through an attenuator. The spectrum analyzer was configured in the following manner. The RBW was set to approximately 1% of the emission bandwidth. The VBW was set to a value greater than or equal to the RBW. The detector was set to peak and trace to max hold. The EUT was operated at its maximum power level on the low, mid, and high test channels. The width of the emission that was 26dB down from the maximum emission was measured.

Plot 1. 26 dB Occupied Bandwidth, Low Channel, 802.11a









Plot 3. 26 dB Occupied Bandwidth, High Channel, 802.11a





Plot 4. 26 dB Occupied Bandwidth, Low Channel, 802.11ac 20 MHz




Plot 5. 26 dB Occupied Bandwidth, Mid Channel, 802.11ac 20 MHz




Plot 6. 26 dB Occupied Bandwidth, High Channel, 802.11ac 20 MHz


Plot 7. 26 dB Occupied Bandwidth, Low Channel, 802.11ac 40 MHz




Plot 9. 26 dB Occupied Bandwidth, 802.11ac 80 MHz





Plot 10. 26 dB Occupied Bandwidth, Low Channel, 802.11n 20 MHz




Plot 11. 26 dB Occupied Bandwidth, Mid Channel, 802.11n 20 MHz




Plot 12. 26 dB Occupied Bandwidth, High Channel, 802.11n 20 MHz







Plot 15. Maximum Conducted Output Power, Low Channel, 802.11a




Plot 16. Maximum Conducted Output Power, Mid Channel, 802.11a




Plot 17. Maximum Conducted Output Power, High Channel, 802.11a





Plot 18. Maximum Conducted Output Power, Low Channel, 802.11ac 20 MHz




Plot 19. Maximum Conducted Output Power, Mid Channel, 802.11ac 20 MHz




Plot 20. Maximum Conducted Output Power, High Channel, 802.11ac 20 MHz


Plot 21. Maximum Conducted Output Power, Low Channel, 802.11ac 40 MHz




Plot 23. Maximum Conducted Output Power, 802.11ac 80 MHz





Plot 24. Maximum Conducted Output Power, Low Channel, 802.11n 20 MHz




Plot 25. Maximum Conducted Output Power, Mid Channel, 802.11n 20 MHz




Plot 26. Maximum Conducted Output Power, High Channel, 802.11n 20 MHz

Plot 29. Maximum Power Spectral Density, Low Channel, 802.11a




Plot 30. Maximum Power Spectral Density, Mid Channel, 802.11a




Plot 31. Maximum Power Spectral Density, High Channel, 802.11a





Plot 32. Maximum Power Spectral Density, Low Channel, 802.11ac 20 MHz




Plot 33. Maximum Power Spectral Density, Mid Channel, 802.11ac 20 MHz




Plot 34. Maximum Power Spectral Density, High Channel, 802.11ac 20 MHz


Plot 35. Maximum Power Spectral Density, Low Channel, 802.11ac 40 MHz




Plot 37. Maximum Power Spectral Density, 802.11ac 80 MHz





Plot 38. Maximum Power Spectral Density, Low Channel, 802.11n 20 MHz




Plot 39. Maximum Power Spectral Density, Mid Channel, 802.11n 20 MHz




Plot 40. Maximum Power Spectral Density, High Channel, 802.11n 20 MHz

Plot 41. Maximum Power Spectral Density, Low Channel, 802.11n 40 MHz




Plot 42. Maximum Power Spectral Density, High Channel, 802.11n 40 MHz








Plot 43. Radiated Spurious Emissions, Low Channel, 802.11a, 30 MHz - 1 GHz




Plot 4. Radiated Spurious Emissions, Low Channel, 802.11a, 1 GHz – 7 GHz, Average






Plot 44. Radiated Spurious Emissions, Low Channel, 802.11a, 1 GHz - 7 GHz, Peak




Plot 45. Radiated Spurious Emissions, High Channel, 802.11a, 1 GHz – 7 GHz, Average






Plot 46. Radiated Spurious Emissions, High Channel, 802.11a, 1 GHz – 7 GHz, Peak







Plot 47. Radiated Spurious Emissions, Low Channel, 802.11ac 20 MHz, 1 GHz – 7 GHz, Average




Plot 48. Radiated Spurious Emissions, Low Channel, 802.11ac 20 MHz, 1 GHz – 7 GHz, Peak






Plot 49. Radiated Spurious Emissions, High Channel, 802.11ac 20 MHz, 1 GHz – 7 GHz, Average




Plot 50. Radiated Spurious Emissions, High Channel, 802.11ac 20 MHz, 1 GHz – 7 GHz, Peak







Plot 51. Radiated Spurious Emissions, Low Channel, 802.11ac 40 MHz, 1 GHz – 7 GHz, Average




Plot 52. Radiated Spurious Emissions, Low Channel, 802.11ac 40 MHz, 1 GHz – 7 GHz, Peak






Plot 53. Radiated Spurious Emissions, High Channel, 802.11ac 40 MHz, 1 GHz – 7 GHz, Average




Plot 54. Radiated Spurious Emissions, High Channel, 802.11ac 40 MHz, 1 GHz – 7 GHz, Peak







Plot 55. Radiated Spurious Emissions, 802.11ac 80 MHz, 1 GHz – 7 GHz, Average




Plot 56. Radiated Spurious Emissions, 802.11ac 80 MHz, 1 GHz – 7 GHz, Peak







Plot 57. Radiated Spurious Emissions, Low Channel, 802.11n 20 MHz, 1 GHz – 7 GHz, Average




Plot 58. Radiated Spurious Emissions, Low Channel, 802.11n 20 MHz, 1 GHz – 7 GHz, Peak






Plot 59. Radiated Spurious Emissions, High Channel, 802.11n 20 MHz, 1 GHz – 7 GHz, Average




Plot 60. Radiated Spurious Emissions, High Channel, 802.11n 20 MHz, 1 GHz – 7 GHz, Peak







Plot 61. Radiated Spurious Emissions, Low Channel, 802.11n 40 MHz, 1 GHz – 7 GHz, Average




Plot 62. Radiated Spurious Emissions, Low Channel, 802.11n 40 MHz, 1 GHz – 7 GHz, Peak






Plot 63. Radiated Spurious Emissions, High Channel, 802.11n 40 MHz, 1 GHz – 7 GHz, Average




Plot 64. Radiated Spurious Emissions, High Channel, 802.11n 40 MHz, 1 GHz – 7 GHz, Peak






Plot 65. Radiated Band Edge, Low Channel, 802.11a, Average




Plot 66. Radiated Band Edge, Low Channel, 802.11a, Peak








Plot 67. Radiated Band Edge, High Channel, 802.11a, Average




Plot 68. Radiated Band Edge, High Channel, 802.11a, Peak




Plot 69. Radiated Band Edge, Low Channel, 802.11ac 20 MHz, Average




Plot 70. Radiated Band Edge, Low Channel, 802.11ac 20 MHz, Peak






Plot 71. Radiated Band Edge, High Channel, 802.11ac 20 MHz, Average




Plot 72. Radiated Band Edge, High Channel, 802.11ac 20 MHz, Peak




Plot 73. Radiated Band Edge, Low Channel, 802.11ac 40 MHz, Average




Plot 74. Radiated Band Edge, Low Channel, 802.11ac 40 MHz, Peak






Plot 75. Radiated Band Edge, High Channel, 802.11ac 40 MHz, Average




Plot 76. Radiated Band Edge, High Channel, 802.11ac 40 MHz, Peak


Plot 77. Radiated Band Edge, 802.11ac 80 MHz, Average




Plot 78. Radiated Band Edge, 802.11ac 80 MHz, Peak




Plot 79. Radiated Band Edge, Low Channel, 802.11n 20 MHz, Average




Plot 80. Radiated Band Edge, Low Channel, 802.11n 20 MHz, Peak






Plot 81. Radiated Band Edge, High Channel, 802.11n 20 MHz, Average




Plot 82. Radiated Band Edge, High Channel, 802.11n 20 MHz, Peak




Plot 83. Radiated Band Edge, Low Channel, 802.11n 40 MHz, Average




Plot 84. Radiated Band Edge, Low Channel, 802.11n 40 MHz, Peak


§ 15.407(g)	Frequency Stability
Test Requirements:	§ 15.407(g): Manufacturers of U-NII devices are responsible for ensuring frequency stability such that an emission is maintained within the band of operation under all conditions of normal operation as specified in the user's manual.
Test Procedure:	The EUT was placed in an environmental chamber and powered through a variable supply. The RF port was connected to a spectrum analyzer through an attenuator. The EUT was set to transmit at the low and high channels and evaluated using the marker delta method. For the low channel, marker 1 was placed at the lower bandedge frequency and marker 2 at the channels peak amplitude. This was repeated for the high channel. The EUT is considered compliant if the amplitude difference between markers 1 and 2 is at least 26dB. The EUT was evaluated at its extreme operating voltages and temperature conditions in 10 degree C increments. Data is presented for normal and extreme conditions.
Test Results:	The EUT was found compliant with the requirements of this section.





Frequency Stability -20°C 97VAC



Plot 89. Frequency Stability, 80211a 20 MHz, -20°C 97VAC









Plot 91. Frequency Stability, 80211n 20 MHz, -20°C 97VAC






Plot 92. Frequency Stability, 80211n 40 MHz, -20°C 97VAC




Plot 93. Frequency Stability, 80211ac 40 MHz, -20°C 97VAC




Plot 94. Frequency Stability, 80211ac 80 MHz, -20°C 97VAC





Frequency Stability 20°C 115VAC



Plot 95. Frequency Stability, 80211a 20 MHz, 20°C 115 VAC









Plot 97. Frequency Stability, 80211n 20 MHz, 20°C 115 VAC






Plot 98. Frequency Stability, 80211n 40 MHz, 20°C 115 VAC




Plot 99. Frequency Stability, 80211ac 40 MHz, 20°C 115 VAC




Plot 100. Frequency Stability, 80211ac 80 MHz, 20°C 115 VAC





Frequency Stability 20°C 115VAC



Plot 101. Frequency Stability, 80211a 20 MHz, 20°C 115 VAC









Plot 103. Frequency Stability, 80211n 20 MHz, 20°C 115 VAC






Plot 104. Frequency Stability, 80211n 40 MHz, 20°C 115 VAC

L. Certification Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 2, Subpart I — Marketing of Radio frequency devices:

§ 2.801 Radio-frequency device defined.

As used in this part, a radio-frequency device is any device which in its operation is capable of Emitting radio-frequency energy by radiation, conduction, or other means. Radio- frequency devices include, but are not limited to:

- (a) The various types of radio communication transmitting devices described throughout this chapter.
- (b) The incidental, unintentional and intentional radiators defined in Part 15 of this chapter.
- (c) The industrial, scientific, and medical equipment described in Part 18 of this chapter.
- (d) Any part or component thereof which in use emits radio-frequency energy by radiation, conduction, or other means.

§ 2.803 Marketing of radio frequency devices prior to equipment authorization.

- (a) Except as provided elsewhere in this chapter, no person shall sell or lease, or offer for sale or lease (including advertising for sale or lease), or import, ship or distribute for the purpose of selling or leasing or offering for sale or lease, any radio frequency device unless:
 - (1) In the case of a device subject to certification, such device has been authorized by the Commission in accordance with the rules in this chapter and is properly identified and labeled as required by §2.925 and other relevant sections in this chapter; or
 - (2) In the case of a device that is not required to have a grant of equipment authorization issued by the Commission, but which must comply with the specified technical standards prior to use, such device also complies with all applicable administrative (including verification of the equipment or authorization under a Declaration of Conformity, where required), technical, labeling and identification requirements specified in this chapter.
- (d) Notwithstanding the provisions of paragraph (a) of this section, the offer for sale solely to business, commercial, industrial, scientific or medical users (but not an offer for sale to other parties or to end users located in a residential environment) of a radio frequency device that is in the conceptual, developmental, design or preproduction stage is permitted prior to equipment authorization or, for devices not subject to the equipment authorization requirements, prior to a determination of compliance with the applicable technical requirements *provided* that the prospective buyer is advised in writing at the time of the offer for sale that the equipment is subject to the FCC rules and that the equipment will comply with the appropriate rules before delivery to the buyer or to centers of distribution.



- (e)(1) Notwithstanding the provisions of paragraph (a) of this section, prior to equipment authorization or determination of compliance with the applicable technical requirements any radio frequency device may be operated, but not marketed, for the following purposes and under the following conditions:
 - (*i*) *Compliance testing;*
 - (ii) Demonstrations at a trade show provided the notice contained in paragraph (c) of this section is displayed in a conspicuous location on, or immediately adjacent to, the device;
 - (iii) Demonstrations at an exhibition conducted at a business, commercial, industrial, scientific or medical location, but excluding locations in a residential environment, provided the notice contained in paragraphs (c) or (d) of this section, as appropriate, is displayed in a conspicuous location on, or immediately adjacent to, the device;
 - (iv) Evaluation of product performance and determination of customer acceptability, provided such operation takes place at the manufacturer's facilities during developmental, design or pre-production states; or
 - (v) Evaluation of product performance and determination of customer acceptability where customer acceptability of a radio frequency device cannot be determined at the manufacturer's facilities because of size or unique capability of the device, provided the device is operated at a business, commercial, industrial, scientific or medical user's site, but not at a residential site, during the development, design or pre-production stages.
- (e)(2) For the purpose of paragraphs (e)(1)(iv) and (e)(1)(v) of this section, the term *manufacturer's facilities* includes the facilities of the party responsible for compliance with the regulations and the manufacturer's premises, as well as the facilities of other entities working under the authorization of the responsible party in connection with the development and manufacture, but not the marketing, of the equipment.
- (f) For radio frequency devices subject to verification and sold solely to business, commercial, industrial, scientific and medical users (excluding products sold to other parties or for operation in a residential environment), parties responsible for verification of the devices shall have the option of ensuring compliance with the applicable technical specifications of this chapter at each end user's location after installation, provided that the purchase or lease agreement includes a proviso that such a determination of compliance be made and is the responsibility of the party responsible for verification of the equipment.



The following is extracted from Title 47 of the Code of Federal Regulations, Part 2, Subpart J — Equipment Authorization Procedures:

§ 2.901 Basis and Purpose

- (a) In order to carry out its responsibilities under the Communications Act and the various treaties and international regulations, and in order to promote efficient use of the radio spectrum, the Commission has developed technical standards for radio frequency equipment and parts or components thereof. The technical standards applicable to individual types of equipment are found in that part of the rules governing the service wherein the equipment is to be operated.¹ *In addition to the technical standards provided, the rules governing the service may require that such equipment be verified by the manufacturer or importer*, be authorized under a Declaration of Conformity, or receive an equipment authorization from the Commission by one of the following procedures: certification or registration.
- (b) The following sections describe the verification procedure, the procedure for a Declaration of Conformity, and the procedures to be followed in obtaining certification from the Commission and the conditions attendant to such a grant.

§ 2.907 Certification.

- (a) Certification is an equipment authorization issued by the Commission, based on representation and test data submitted by the applicant.
- (b) Certification attaches to all units subsequently marketed by the grantee which are identical (see Section 2.908) to the sample tested except for permissive changes or other variations authorized by the Commission pursuant to Section 2.1043.

¹ In this case, the equipment is subject to the rules of Part 15. More specifically, the equipment falls under Subpart B (of Part 15), which deals with unintentional radiators.



§ 2.948 Description of measurement facilities.

(a) Each party making measurements of equipment that is subject to an equipment authorization under Part 15 or Part 18 of this chapter, regardless of whether the measurements are filed with the Commission or kept on file by the party responsible for compliance of equipment marketed within the U.S. or its possessions, shall compile a description of the measurement facilities employed.

(1) If the measured equipment is subject to the verification procedure, the description of the measurement facilities shall be retained by the party responsible for verification of the equipment.

- (i) If the equipment is verified through measurements performed by an independent laboratory, it is acceptable for the party responsible for verification of the equipment to rely upon the description of the measurement facilities retained by or placed on file with the Commission by that laboratory. In this situation, the party responsible for the verification of the equipment is not required to retain a duplicate copy of the description of the measurement facilities.
- (ii) If the equipment is verified based on measurements performed at the installation site of the equipment, no specific site calibration data is required. It is acceptable to retain the description of the measurement facilities at the site at which the measurements were performed.
- (2) If the equipment is to be authorized by the Commission under the certification procedure, the description of the measurement facilities shall be filed with the Commission's Laboratory in Columbia, Maryland. The data describing the measurement facilities need only be filed once but must be updated as changes are made to the measurement facilities or as otherwise described in this section. At least every three years, the organization responsible for filing the data with the Commission shall certify that the data on file is current.



Label and User's Manual Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 15, Subpart A — General:

§ 15.19 Labeling requirements.

- (a) In addition to the requirements in Part 2 of this chapter, a device subject to certification or verification shall be labeled as follows:
 - (1) Receivers associated with the operation of a licensed radio service, e.g., FM broadcast under Part 73 of this chapter, land mobile operation under Part 90, etc., shall bear the following statement in a conspicuous location on the device:

This device complies with Part 15 of the FCC Rules. Operation is subject to the condition that this device does not cause harmful interference.

(2) A stand-alone cable input selector switch, shall bear the following statement in a conspicuous location on the device:

This device is verified to comply with Part 15 of the FCC Rules for use with cable television service.

(3) All other devices shall bear the following statement in a conspicuous location on the device:

This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) This device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.

- (4) Where a device is constructed in two or more sections connected by wires and marketed together, the statement specified under paragraph (a) of this section is required to be affixed only to the main control unit.
- (5) When the device is so small or for such use that it is not practicable to place the statement specified under paragraph (a) of this section on it, the information required by this paragraph shall be placed in a prominent location in the instruction manual or pamphlet supplied to the user or, alternatively, shall be placed on the container in which the device is marketed. However, the FCC identifier or the unique identifier, as appropriate, must be displayed on the device.

§ 15.21 Information to user.

The users manual or instruction manual for an intentional or unintentional radiator shall caution the user that changes or modifications not expressly approved by the party responsible for compliance could void the user's authority to operate the equipment.



The following is extracted from Title 47 of the Code of Federal Regulations, Part 15, Subpart B — Unintentional Radiators:

§ 15.105 Information to the user.

(a) For a Class A digital device or peripheral, the instructions furnished the user shall include the following or similar statement, placed in a prominent location in the text of the manual:

Note: This equipment has been tested and found to comply with the limits for a Class A digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference when the equipment is operated in a commercial environment. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instruction manual, may cause harmful interference to radio communications. Operation of this equipment in a residential area is likely to cause harmful interference in which case the user will be required to correct the interference at own expense.

(b) For a Class B digital device or peripheral, the instructions furnished the user shall include the following or similar statement, placed in a prominent location in the text of the manual:

Note: This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference when the equipment is operated in a residential environment. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instruction manual, may cause harmful interference to radio communications. However, there is no guarantee that interference will not occur in a particular installation. If this equipment does cause harmful interference to radio or television reception, which can be determined by turning the equipment off and on, the user is encouraged to try to correct the interference by one or more of the following measures:

- Reorient or relocate the receiving antenna.
- Increase the separation between the equipment and receiver.
- Connect the equipment into an outlet on a circuit different from that to which the receiver is connected.
- Consult the dealer or an experienced radio/TV technician for help.
