

I. Executive Summary



A. Purpose of Test

An EMC evaluation was performed to determine compliance of the ARRIS Group, Inc. SBG7400, with the requirements of Part 15, §15.407. All references are to the most current version of Title 47 of the Code of Federal Regulations in effect. In accordance with §2.1033, the following data is presented in support of the Certification of the SBG7400. ARRIS Group, Inc. should retain a copy of this document which should be kept on file for at least two years after the manufacturing of the SBG7400, has been **permanently** discontinued.

B. Executive Summary

The following tests were conducted on a sample of the equipment for the purpose of demonstrating compliance with Part 15, §15.407, in accordance with ARRIS Group, Inc., purchase order number AR1098306. All tests were conducted using measurement procedure ANSI C63.4-2014.

C. Test Site

All testing was performed at MET Laboratories, Inc., 914 West Patapsco Avenue, Baltimore MD 21230. All equipment used in making physical determinations is accurate and bears recent traceability to the National Institute of Standards and Technology.

Radiated Emissions measurements were performed in a 3 meter semi-anechoic chamber (equivalent to an Open Area Test Site). In accordance with §2.948(a)(3), a complete site description is contained at MET Laboratories.

D. Description of Test Sample

The ARRIS Group, Inc. SBG7400, Equipment Under Test (EUT), is identical to TG2482 except no telephony circuitry.

The TG2482 is Telephony Gateway with 802.11ac Dual Band Wireless radios; 3x3 2.4GHz 802.11n and 4x4 5GHz 802.11ac Wave 2.




Figure 1. Block Diagram of Test Configuration



§ 15.203 Antenna Requirement

Test Requirement: § 15.203: An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

The structure and application of the EUT were analyzed to determine compliance with Section 15.203 of the Rules. Section 15.203 states that the subject device must meet at least one of the following criteria

- a.) Antenna must be permanently attached to the unit.
- b.) Antenna must use a unique type of connector to attach to the EUT.
- c.) Unit must be professionally installed. Installer shall be responsible for verifying that the correct antenna is employed with the unit.
- **Results:** The EUT as tested is compliant the criteria of §15.203. The EUT has integral antennas. The EUT also has test ports for conducted measurements.

- **§15.** 407(a)(3) Maximum Conducted Output Power
- Test Requirements:\$15.407(a)(3): For the band 5.725-5.85 GHz, the maximum conducted output power over the
frequency band of operation shall not exceed 1 W.
If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum
conducted output power and the maximum power spectral density shall be reduced by the
amount in dB that the directional gain of the antenna exceeds 6 dBi. However, fixed point-to-
point U-NII devices operating in this band may employ transmitting antennas with directional
gain greater than 6 dBi without any corresponding reduction in transmitter conducted power.
- **Test Procedure:** The Maximum Conducted Output Power was measured according to KDB789033 v01r03 Method SA-1. The EUT was connected to the spectrum analyzer through an attenuator. The spectrum analyzer was configured in the following manner. The span was set to encompass the entire emission bandwidth of the signal. The RBW was set to 1MHz and the VBW was set to a value greater than or equal to 3x the RBW. An average detector was used with an auto sweep time. The trace was averaged over at least 100 traces. Power was computed by integrating the spectrum across the EBW of the signal using the instruments band power measurement function.
- **Test Results:** The EUT as tested is compliant with the requirements of this section. Graphical data is presented for chain 0. Tabular data is presented for all chains. Data is uncorrelated for n and ac modes.





Plot 2. Maximum Conducted Output Power, BW 20M, Ch 5745M, 80211ac, MCS24, P3230 CH0




Plot 3. Maximum Conducted Output Power, BW 20M, Ch 5745M, 80211n, MSC24, P3230, CH0



Plot 5. Maximum Conducted Output Power, BW 20M, Ch 5785M, 80211ac, MCS24, P3230, CH0




Plot 6. Maximum Conducted Output Power, BW 20M, Ch 5785M, 80211n, MSC24, P3230, CH0



Plot 8. Maximum Conducted Output Power, BW 20M, Ch 5825M, 80211ac, MSC24, P3230, CH0




Plot 9. Maximum Conducted Output Power, BW 20M, Ch 5825M, 80211n MSC24, P3230, CH0



Plot 10. Maximum Conducted Output Power, BW 40M, Ch 5755M, 80211ac, MCS24 P3230, CH0




Plot 11. Maximum Conducted Output Power, BW 40M, Ch 5755M, 80211n, MSC24 P3230, CH0




Plot 12. Maximum Conducted Output Power, BW 40M, Ch 5795M, 80211ac, MCS24, P3230, CH0






Plot 13. Maximum Conducted Output Power, BW 40M, Ch 5795M, 80211n, MSC24, P3230, CH0













Plot 15. Power Spectral Density, BW 20M, Ch 5745M, 80211a, MSC0, P3230, CH0




Plot 16. Power Spectral Density, BW 20M, Ch 5745M, 80211ac, MCS24, P3230, CH0




Plot 17. Power Spectral Density, BW 20M, Ch 5745M, 80211n, MSC24, P3230, CH0






Plot 18. Power Spectral Density, BW 20M, Ch 5785M, 80211a, MSC0, P3230, CH0




Plot 19. Power Spectral Density, BW 20M, Ch 5785M, 80211ac, MCS24, P3230, CH0




Plot 20. Power Spectral Density, BW 20M, Ch 5785M, 80211n, MSC24, P3230, CH0






Plot 21. Power Spectral Density, BW 20M, Ch 5825M, 80211a, MSC0, P3230, CH0




Plot 22. Power Spectral Density, BW 20M, Ch 5825M, 80211ac, MSC24, P3230, CH0




Plot 23. Power Spectral Density, BW 20M, Ch 5825M, 80211n, MSC24, P3230, CH0






Plot 24. Power Spectral Density, BW 40M, Ch 5755M, 80211ac, MCS24, P3230 CH0




Plot 25. Power Spectral Density, BW 40M, Ch 5755M, 80211n, MCS24, P3230, CH0




Plot 26. Power Spectral Density, BW 40M, Ch 5795M, 80211ac, MCS24, P3230, CH0





Plot 27. Power Spectral Density, BW 40M, Ch 5795M, 80211n, MSC24, P3230, CH0




Plot 28. Power Spectral Density, BW 80M, Ch 5775M, 80211ac, MSC24, P3230, CH0








Plot 29. Undesirable Emissions, BW 20M, Ch 5745M, 80211a, MCS0, P3230




Plot 30. Undesirable Emissions, BW 20M, Ch 5745M, 80211ac, MCS24, P3230




Plot 31. Undesirable Emissions, BW 20M, Ch 5745M, 80211n, MCS24, P3230






Plot 32. Undesirable Emissions, BW 20M, Ch 5825M, 80211a, MCS0, P3230




Plot 33. Undesirable Emissions, BW 20M, Ch 5825M, 80211ac, MCS24, P3230




Plot 34. Undesirable Emissions, BW 20M, Ch 5825M, 80211n, MCS24, P3230






Plot 35. Undesirable Emissions, BW 40M, Ch 5755M, 80211ac, MCS24, P3230




Plot 36. Undesirable Emissions, BW 40M, Ch 5755M, 80211n, MCS24, P3230




Plot 37. Undesirable Emissions, BW 40M, Ch 5795M, 80211ac, MCS24, P3230






Plot 38. Undesirable Emissions, BW 40M, Ch 5795M, 80211n, MCS24, P3230





Plot 39. Undesirable Emissions, BW 80M, Ch 5775M, 7-18GHz


Plot 42. Undesirable Emissions, 30M – 1GHz-18GHz







Plot 43. Band Edge, BW 20M, Ch 5745M, 80211a, MCS0, P3230









Plot 45. Band Edge, BW 20M, Ch 5745M, 80211n, MCS24, P3230






Plot 46. Band Edge, BW 20M, Ch 5825M, 80211a, MCS0, P3230




Plot 47. Band Edge, BW 20M, Ch 5825M, 80211ac, MCS24, P3230




Plot 48. Band Edge, BW 20M, Ch 5825M, 80211n, MCS24, P3230






Plot 49. Band Edge, BW 40M, Ch 5755M, 80211ac, MCS24, P3230




Plot 50. Band Edge, BW 40M, Ch 5755M, 80211n, MCS24, P3230




Plot 51. Band Edge, BW 40M, Ch 5795M, 80211ac, MCS24, P3230





Plot 55. Conducted Emissions, Phase












Plot 56. 6 dB Bandwidth, BW 20M, Ch 5745M, 80211a, MCS0, P3230, CH0




Plot 57. 6 dB Bandwidth, BW 20M, Ch 5745M, 80211ac, MCS24, P3230, CH0




Plot 58. 6 dB Bandwidth, BW 20M, Ch 5745M, 80211n, MCS16, P3230, CH0






Plot 59. 6 dB Bandwidth, BW 20M, Ch 5785M, 80211a, MCS0, P3230, CH0




Plot 60. 6 dB Bandwidth, BW 20M, Ch 5785M, 80211ac, MCS24, P3230, CH0




Plot 61. 6 dB Bandwidth, BW 20M, Ch 5785M, 80211n, MCS16, P3230, CH0






Plot 62. 6 dB Bandwidth, BW 20M, Ch 5825M, 80211a, MCS0, P3230, CH0




Plot 63. 6 dB Bandwidth, BW 20M, Ch 5825M, 80211ac, MCS24, P3230, CH0




Plot 64. 6 dB Bandwidth, BW 20M, Ch 5825M, 80211n, MCS16, P3230, CH0






Plot 65. 6 dB Bandwidth, BW 40M, Ch 5755M, 80211ac, MCS24, P3230, CH0




Plot 66. 6 dB Bandwidth, BW 40M, Ch 5755M, 80211n, MCS16, P3230, CH0




Plot 67. 6 dB Bandwidth, BW 40M, Ch 5795M, 80211ac, MCS24, P3230, CH0





Test Requirements:	§ 15.407(g): Manufacturers of U-NII devices are responsible for ensuring frequency stability such that an emission is maintained within the band of operation under all conditions of normal operation as specified in the user's manual.
Test Procedure:	The EUT was placed in an environmental chamber and powered through a variable supply. The RF port was connected to a spectrum analyzer through an attenuator. The EUT was set to transmit at the low and high channels and evaluated using the marker delta method. For the low channel, marker 1 was placed at the lower band edge frequency and marker 2 at the channels peak amplitude. This was repeated for the high channel. The EUT is considered compliant if the amplitude difference between markers 1 and 2 is at least 26dB. 



Frequency Stability -20C 97VAC



Plot 70. Frequency Stability, 80211a BW 20MHz










Plot 72. Frequency Stability, 80211n BW 20MHz
















Plot 75. Frequency Stability, 80211ac BW 80MHz





Frequency Stability 20C 115VAC



Plot 76. Frequency Stability, 80211a BW 20MHz









Plot 78. Frequency Stability, 80211n BW 20MHz











Plot 80. Frequency Stability, 80211ac BW 40MHz




Plot 81. Frequency Stability, 80211ac BW 80MHz





Frequency Stability 40C 133VAC



Plot 82. Frequency Stability, 80211a BW 20MHz









Plot 84. Frequency Stability, 80211n BW 20MHz










Plot 86. Frequency Stability, 80211ac BW 40MHz

K. Certification Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 2, Subpart I — Marketing of Radio frequency devices:

§ 2.801 Radio-frequency device defined.

As used in this part, a radio-frequency device is any device which in its operation is capable of Emitting radio-frequency energy by radiation, conduction, or other means. Radio- frequency devices include, but are not limited to:

- (a) The various types of radio communication transmitting devices described throughout this chapter.
- (b) The incidental, unintentional and intentional radiators defined in Part 15 of this chapter.
- (c) The industrial, scientific, and medical equipment described in Part 18 of this chapter.
- (d) Any part or component thereof which in use emits radio-frequency energy by radiation, conduction, or other means.

§ 2.803 Marketing of radio frequency devices prior to equipment authorization.

- (a) Except as provided elsewhere in this chapter, no person shall sell or lease, or offer for sale or lease (including advertising for sale or lease), or import, ship or distribute for the purpose of selling or leasing or offering for sale or lease, any radio frequency device unless:
 - (1) In the case of a device subject to certification, such device has been authorized by the Commission in accordance with the rules in this chapter and is properly identified and labeled as required by §2.925 and other relevant sections in this chapter; or
 - (2) In the case of a device that is not required to have a grant of equipment authorization issued by the Commission, but which must comply with the specified technical standards prior to use, such device also complies with all applicable administrative (including verification of the equipment or authorization under a Declaration of Conformity, where required), technical, labeling and identification requirements specified in this chapter.
- (d) Notwithstanding the provisions of paragraph (a) of this section, the offer for sale solely to business, commercial, industrial, scientific or medical users (but not an offer for sale to other parties or to end users located in a residential environment) of a radio frequency device that is in the conceptual, developmental, design or preproduction stage is permitted prior to equipment authorization or, for devices not subject to the equipment authorization requirements, prior to a determination of compliance with the applicable technical requirements *provided* that the prospective buyer is advised in writing at the time of the offer for sale that the equipment is subject to the FCC rules and that the equipment will comply with the appropriate rules before delivery to the buyer or to centers of distribution.



- (e)(1) Notwithstanding the provisions of paragraph (a) of this section, prior to equipment authorization or determination of compliance with the applicable technical requirements any radio frequency device may be operated, but not marketed, for the following purposes and under the following conditions:
 - (*i*) *Compliance testing*;
 - (ii) Demonstrations at a trade show provided the notice contained in paragraph (c) of this section is displayed in a conspicuous location on, or immediately adjacent to, the device;
 - (iii) Demonstrations at an exhibition conducted at a business, commercial, industrial, scientific or medical location, but excluding locations in a residential environment, provided the notice contained in paragraphs (c) or (d) of this section, as appropriate, is displayed in a conspicuous location on, or immediately adjacent to, the device;
 - (iv) Evaluation of product performance and determination of customer acceptability, provided such operation takes place at the manufacturer's facilities during developmental, design or pre-production states; or
 - (v) Evaluation of product performance and determination of customer acceptability where customer acceptability of a radio frequency device cannot be determined at the manufacturer's facilities because of size or unique capability of the device, provided the device is operated at a business, commercial, industrial, scientific or medical user's site, but not at a residential site, during the development, design or pre-production stages.
- (e)(2) For the purpose of paragraphs (e)(1)(iv) and (e)(1)(v) of this section, the term *manufacturer's facilities* includes the facilities of the party responsible for compliance with the regulations and the manufacturer's premises, as well as the facilities of other entities working under the authorization of the responsible party in connection with the development and manufacture, but not the marketing, of the equipment.
- (f) For radio frequency devices subject to verification and sold solely to business, commercial, industrial, scientific and medical users (excluding products sold to other parties or for operation in a residential environment), parties responsible for verification of the devices shall have the option of ensuring compliance with the applicable technical specifications of this chapter at each end user's location after installation, provided that the purchase or lease agreement includes a proviso that such a determination of compliance be made and is the responsibility of the party responsible for verification of the equipment.



The following is extracted from Title 47 of the Code of Federal Regulations, Part 2, Subpart J — Equipment Authorization Procedures:

§ 2.901 Basis and Purpose

- (a) In order to carry out its responsibilities under the Communications Act and the various treaties and international regulations, and in order to promote efficient use of the radio spectrum, the Commission has developed technical standards for radio frequency equipment and parts or components thereof. The technical standards applicable to individual types of equipment are found in that part of the rules governing the service wherein the equipment is to be operated.¹ *In addition to the technical standards provided, the rules governing the service may require that such equipment be verified by the manufacturer or importer*, be authorized under a Declaration of Conformity, or receive an equipment authorization from the Commission by one of the following procedures: certification or registration.
- (b) The following sections describe the verification procedure, the procedure for a Declaration of Conformity, and the procedures to be followed in obtaining certification from the Commission and the conditions attendant to such a grant.

§ 2.907 Certification.

- (a) Certification is an equipment authorization issued by the Commission, based on representation and test data submitted by the applicant.
- (b) Certification attaches to all units subsequently marketed by the grantee which are identical (see Section 2.908) to the sample tested except for permissive changes or other variations authorized by the Commission pursuant to Section 2.1043.

¹ In this case, the equipment is subject to the rules of Part 15. More specifically, the equipment falls under Subpart B (of Part 15), which deals with unintentional radiators.



§ 2.948 Description of measurement facilities.

(a) Each party making measurements of equipment that is subject to an equipment authorization under Part 15 or Part 18 of this chapter, regardless of whether the measurements are filed with the Commission or kept on file by the party responsible for compliance of equipment marketed within the U.S. or its possessions, shall compile a description of the measurement facilities employed.

(1) If the measured equipment is subject to the verification procedure, the description of the measurement facilities shall be retained by the party responsible for verification of the equipment.

- (i) If the equipment is verified through measurements performed by an independent laboratory, it is acceptable for the party responsible for verification of the equipment to rely upon the description of the measurement facilities retained by or placed on file with the Commission by that laboratory. In this situation, the party responsible for the verification of the equipment is not required to retain a duplicate copy of the description of the measurement facilities.
- (ii) If the equipment is verified based on measurements performed at the installation site of the equipment, no specific site calibration data is required. It is acceptable to retain the description of the measurement facilities at the site at which the measurements were performed.
- (2) If the equipment is to be authorized by the Commission under the certification procedure, the description of the measurement facilities shall be filed with the Commission's Laboratory in Columbia, Maryland. The data describing the measurement facilities need only be filed once but must be updated as changes are made to the measurement facilities or as otherwise described in this section. At least every three years, the organization responsible for filing the data with the Commission shall certify that the data on file is current.



Label and User's Manual Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 15, Subpart A — General:

§ 15.19 Labeling requirements.

- (a) In addition to the requirements in Part 2 of this chapter, a device subject to certification or verification shall be labeled as follows:
 - (1) Receivers associated with the operation of a licensed radio service, e.g., FM broadcast under Part 73 of this chapter, land mobile operation under Part 90, etc., shall bear the following statement in a conspicuous location on the device:

This device complies with Part 15 of the FCC Rules. Operation is subject to the condition that this device does not cause harmful interference.

(2) A stand-alone cable input selector switch, shall bear the following statement in a conspicuous location on the device:

This device is verified to comply with Part 15 of the FCC Rules for use with cable television service.

(3) All other devices shall bear the following statement in a conspicuous location on the device:

This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) This device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.

- (4) Where a device is constructed in two or more sections connected by wires and marketed together, the statement specified under paragraph (a) of this section is required to be affixed only to the main control unit.
- (5) When the device is so small or for such use that it is not practicable to place the statement specified under paragraph (a) of this section on it, the information required by this paragraph shall be placed in a prominent location in the instruction manual or pamphlet supplied to the user or, alternatively, shall be placed on the container in which the device is marketed. However, the FCC identifier or the unique identifier, as appropriate, must be displayed on the device.

§ 15.21 Information to user.

The users manual or instruction manual for an intentional or unintentional radiator shall caution the user that changes or modifications not expressly approved by the party responsible for compliance could void the user's authority to operate the equipment.



The following is extracted from Title 47 of the Code of Federal Regulations, Part 15, Subpart B — Unintentional Radiators:

§ 15.105 Information to the user.

(a) For a Class A digital device or peripheral, the instructions furnished the user shall include the following or similar statement, placed in a prominent location in the text of the manual:

Note: This equipment has been tested and found to comply with the limits for a Class A digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference when the equipment is operated in a commercial environment. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instruction manual, may cause harmful interference to radio communications. Operation of this equipment in a residential area is likely to cause harmful interference in which case the user will be required to correct the interference at own expense.

(b) For a Class B digital device or peripheral, the instructions furnished the user shall include the following or similar statement, placed in a prominent location in the text of the manual:

Note: This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference when the equipment is operated in a residential environment. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instruction manual, may cause harmful interference to radio communications. However, there is no guarantee that interference will not occur in a particular installation. If this equipment does cause harmful interference to radio or television reception, which can be determined by turning the equipment off and on, the user is encouraged to try to correct the interference by one or more of the following measures:

- Reorient or relocate the receiving antenna.
- Increase the separation between the equipment and receiver.
- Connect the equipment into an outlet on a circuit different from that to which the receiver is connected.
- Consult the dealer or an experienced radio/TV technician for help.
