9. Test Site Description

Compliance Worldwide is located at 357 Main Street in Sandown, New Hampshire. The test sites at Compliance Worldwide are used for conducted and radiated emissions testing in accordance with Federal Communications Commission (FCC) and Industry Canada standards. A description of the test sites is on file with the FCC (registration number **96392**) and Industry Canada (file number **IC 3023A-1**).

The radiated emissions test site is a 3 and 10 meter enclosed open area test site (OATS). Personnel, support equipment and test equipment are located in the basement beneath the OATS ground plane.

The conducted emissions site is part of a 16' x 20' x 12' ferrite tile chamber and uses one of the walls for the vertical ground plane required by EN 55022.

Both sites are designed to test products or systems 1.5 meter W x 1.5 meter L x 2.0 meter H, floor standing or table top.
