3 SYSTEM TEST CONFIGURATION

3.1 Justification

For both radiated and conducted emissions below 1 GHz, the system was configured for testing in a typical fashion, as a customer would normally use it. The peripherals other than EUT were connected in normally standing by situation. Measurement was performed under the condition that a computer program was exercised to simulate data communication of EUT, and the transmission rate was set to maximum allowed by EUT. Three highest emissions were verified with varying placement of the transmitting antenna connected to EUT to maximize the emission from EUT.

For conducted emissions, only measured on TX / RX and charge mode operation, for the digital circuits portion also function normally whenever TX or RX is operated. For radiated emissions, whichever RF channel is operated, the digital circuits function identically. As the reason, measurement of radiated emissions from digital circuits is only performed by transmitting mode. During the preliminary test, the worse cases are TX / RX and charge mode, and data presented in this test report just shows the worse case.



4.4 Measurement Instrument setting

- 4.4.1 Set the EMI test receiver frequency range from 150 KHz to 30 MHz.
- 4.4.2 Set the EMI test receiver bandwidth at 9kHz.
- 4.4.3 Set the EMI test receiver detector as Quasi-Peak (Q.P.) and Average (AV).

4.5 Configuration of Measurement

- 4.5.1 The EUT was placed on a non-conductive table whose total height equaled 80cm and vertical conducting plane located 40cm to the rear of the EUT.
- 4.5.2 The EUT was connected to the main power through Line Impedance Stabilization Networks (LISN). This setup provided a $50 \text{ohm} / 50 \mu\text{H}$ coupling impedance for the measuring equipment. The auxiliary equipment was also connected to the main power through a LISN that provided a $50 \text{ohm} / 50 \mu\text{H}$ coupling impedance with 50 ohm termination. (Refer to the block diagram of the test setup and photographs.)
- 4.5.3 The conducted disturbance was measured between the phase lead and the reference ground, and between the neutral lead and reference ground. The initial testing identified the frequency that has the highest disturbance relative to the limit while operating the EUT in typical modes of operation and cable positions in a test setup representative of typical system configuration.
- 4.5.4 The identification of the frequency of highest disturbance with respect to the limit was found by investigating disturbances at a number of significant frequencies. The probable frequency of maximum disturbance had been found and that the associated cable and EUT configuration and mode of operation had been identified.





5.4 Block Diagram of Test Configuration


Frequencies measured below 1 GHz configuration

Position the highness when the highest value is indicated on spectrum analyzer, then change the orientation of EUT on test table over a range from 0 or to 360 or with a speed as slow as possible, and keep the azimuth that highest emission is indicated on the spectrum analyzer. Vary the antenna position again and record the highest value as a final reading. A RF test receiver is also used to confirm emissions measured.
- 5.6.5 Note: A band pass filter was used to avoid pre-amplifier saturated when measure TX operation mode in frequency band above 1 GHz.


