The measurement procedure is implemented into the EMI test software ES-K1 from R&S. The radiated emissions measurements were made in a typical installation configuration. Exploratory tests are performed at 3 orthogonal axes to determine the worst-case orientation of a body-worn or handheld EUT. The final test on all kind of EUTs is performed at 2 axes. A pre-check is also performed while the EUT is powered from both AC and DC (battery) power in order to find the worst-case operating condition.

1. Measurement up to 30 MHz

The test set-up was made in accordance to the general provisions of ANSI C63.4.

The Equipment Under Test (EUT) was set up on a non-conductive table in the anechoic chamber.

The radiated emissions measurements were made in a typical installation configuration.

The measurement procedure is implemented into the EMI test software ES-K1 from R&S.

The Loop antenna HFH2-Z2 is used.

Step 1: pre-measurement

- Anechoic chamber
- Antenna distance: 10 m
- Detector: Peak-Maxhold
- Frequency range: 0.009 0.15 and 0.15 30 MHz
- Frequency steps: 0.1 kHz and 5 kHz
- IF-Bandwidth: 0.2 kHz and 10 kHz
- Measuring time / Frequency step: 100 ms

Intention of this step is, to determine the radiated EMI-profile of the EUT. Afterwards the relevant emissions for the final measurement are identified.

Step 2: final measurement

For the relevant emissions determined in step 1, an additional measurement with the following settings will be performed. Intention of this step is to find the maximum emission level.

- Open area test side
- Antenna distance: according to the Standard
- Detector: Quasi-Peak
- Frequency range: 0.009 30 MHz
- Frequency steps: measurement at frequencies detected in step 1
- IF-Bandwidth: 200 Hz 10 kHz
- Measuring time / Frequency step: 100 ms
- 2. Measurement above 30 MHz and up to 1 GHz

Step 1: Preliminary scan

Preliminary test to identify the highest amplitudes relative to the limit.

Settings for step 1:

- Detector: Peak-Maxhold
- Frequency range: 30 1000 MHz
- Frequency steps: 60 kHzIF-Bandwidth: 120 kHz
- Measuring time / Frequency step: 100 μs (BT Timing 1.25 ms)
- Turntable angle range: -180 to +180°

- Turntable step size: 90°

- Height variation range: 1 - 3 m - Height variation step size: 2 m Polarisation: Horizontal + Vertical

Intention of this step is, to determine the radiated EMI-profile of the EUT. Afterwards the relevant emissions for the final measurement are identified.

Step 2: second measurement

For the relevant emissions determined in step 1, an additional measurement with the following settings will be performed. Intention of this step is, to find out the approximate turntable angle and antenna height for each frequency.

- Detector: Peak - Maxhold

- Measured frequencies: in step 1 determined frequencies

- IF - Bandwidth: 120 kHz - Measuring time: 100 ms

- Turntable angle range: -180 to +180° - Turntable step size: 45°

- Height variation range: 1 - 4 m - Height variation step size: 0.5 m Polarisation: horizontal + vertical

After this step the EMI test system has determined the following values for

each frequency (of step 1):

- Frequency

- Azimuth value (of turntable)

- Antenna height

The last two values have now the following accuracy:

- Azimuth value (of turntable): 45°

- Antenna height: 0.5 m Step 3: final measurement

In this step the accuracy of the turntable azimuth and antenna height will be improved. This is necessary to find out the maximum value of every frequency.

For each frequency, which was determined the turntable azimuth and antenna height will be adjusted. The turntable azimuth will be slowly varied by $+/-22.5^{\circ}$ around this value. During this action the value of emission is continuously measured. The turntable azimuth at the highest emission will be recorded and adjusted. In this position the antenna height is also slowly varied by ± -25 cm around the antenna height determined. During this action the value of emission is also continuously measured. The antenna height of the highest emission will also be recorded and adjusted.

- Detector: Peak - Maxhold

- Measured frequencies: in step 1 determined frequencies

- IF - Bandwidth: 120 kHz - Measuring time: 100 ms

- Turntable angle range: -22.5° to +22.5° around the determined value

- Height variation range: -0.25 m to +0.25 m around the determined value

Step 4: final measurement with QP detector

With the settings determined in step 3, the final measurement will be performed:

EMI receiver settings for step 4:

- Detector: Quasi-Peak (< 1 GHz)

- Measured frequencies: in step 1 determined frequencies

- IF - Bandwidth: 120 kHz - Measuring time: 1 s

3. Measurement above 1 GHz

The following modifications apply to the measurement procedure for the frequency range above 1 GHz: The measurement distance was reduced to 1 m. The results were extrapolated by the extrapolation factor of 20 dB/decade (inverse linear-distance for field strength measurements, inverse linear-distance squared for the power reference level measurements). Due to the fact that in this frequency range a double ridged wave guided horn antenna (up to 18 GHz) and a horn antenna (18-25 GHz) are used, the steps 2-4 are omitted. Step 1 was performed with one height of the receiving antenna only.

EMI receiver settings:

- Detector: Peak, Average

- IF Bandwidth = 1 MHz

After the measurement a plot will be generated which contains a diagram with the results of the preliminary scan and a chart with the frequencies and values of the results of the final measurement.

For the enhanced data rate packets the test is performed as worst-case-check in order to verify that emissions have a comparable level as found at basic data rate. Typically, the measurement for these packets is performed in the frequency range 1 to 8 GHz but it depends on the emissions found during the test for the basic data rate. Please refer to the results for the used frequency range.

The Equipment Under Test (EUT) was set up to perform the dwell time measurements. The EUT was connected to the spectrum analyzer via a short coax cable. The dwell time is calculated by:

Dwell time = time slot length * hop rate / number of hopping channels * 31.6 s

- hop rate = 1600 * 1/s for DH1 packets = 1600 s-1
- hop rate = 1600/3 * 1/s for DH3 packets = 533.33 s-1
- hop rate = 1600/5 * 1/s for DH5 packets = 320 s-1
- number of hopping channels = 79
- 31.6 s = 0.4 seconds multiplied by the number of hopping channels = 0.4 s * 79

The highest value of the dwell time is reported.


