2 Overview of subjects to be delivered by applicant.

An application must consist of at least the information as listed in the "subject" column. Where applicable is a document i.d. given as example to help the applicant.

2.1 Required format

To be able to deliver the requested type certification within the shortest timeframe, the (compressed) application packages containing the requested exhibits should be uploaded in the requested format to the customer specific ftp folder, which can be accessed at http://www.telefication.com/ftp2/.

Applications for FCC can only be handled when submitted in PDF or JPG. The size of each file shall be less than 6 Mbyte! Similar exhibits types should be combined into one file, e.g. please do not sent separate internal photos, but provide them combine into 1 file. The same accounts for external photos, etc. All application information according to 47 CFR 2.1033 requirements can be found on the FCC-Website.
