This can lead to losing this project to competitors and a big financial loss to **Logicdata Electronic & Software Entwicklungs GmbH**, which invested a huge amount of time and money in this project. **Logicdata Electronic & Software Entwicklungs GmbH** and all involved parties in this project, such as its OEM customer and all sub-suppliers are bound to non-disclosure agreements to prevent unauthorized disclosure. None of the above listed exhibits are currently available to the public. Again we want to express the necessity of confidentiality due to the high investments of **Logicdata Electronic & Software Entwicklungs GmbH** for this project.

### Short Term Confidentiality


In addition to the above mentioned documents, pursuant to Public Notice DA 04-1705 of the Commission's policy, in order to comply with the marketing regulations in 47 CFR §2.803 and the importation rules in 47 CFR § 2.1204, while ensuring that business sensitive information remains confidential until the actual marketing of newly authorized devices, on behalf of **Logicdata Electronic & Software Entwicklungs GmbH** it is requested that the Commission withholds the following documents from public viewing until 31<sup>st</sup> August 2012:
