



802.11b TEST RESULTTEST PLOT OF BANDWIDTH FOR LOW CHANNEL




TEST PLOT OF BANDWIDTH FOR MIDDLE CHANNEL



TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL




802.11g TEST RESULTTEST PLOT OF BANDWIDTH FOR LOW CHANNEL



TEST PLOT OF BANDWIDTH FOR MIDDLE CHANNEL




TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL



802.11n (20) TEST RESULTTEST PLOT OF BANDWIDTH FOR LOW CHANNEL




TEST PLOT OF BANDWIDTH FOR MIDDLE CHANNEL





TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL




802.11n(40) TEST RESULT

TEST PLOT OF BANDWIDTH FOR LOW CHANNEL




TEST PLOT OF OUT OF BAND EMISSIONS OF 802.11b FOR MODULATION IN MIDDLE CHANNEL








TEST PLOT OF OUT OF BAND EMISSIONS OF 802.11b FOR MODULATION IN HIGH CHANNEL





802.11b TEST RESULTTEST PLOT OF SPECTRAL DENSITY FOR LOW CHANNEL




TEST PLOT OF SPECTRAL DENSITY FOR MIDDLE CHANNEL




TEST PLOT OF SPECTRAL DENSITY FOR HIGH CHANNEL




802.11g TEST RESULTTEST PLOT OF SPECTRAL DENSITY FOR LOW CHANNEL



TEST PLOT OF SPECTRAL DENSITY FOR MIDDLE CHANNEL




TEST PLOT OF SPECTRAL DENSITY FOR HIGH CHANNEL



TEST PLOT OF SPECTRAL DENSITY FOR LOW CHANNEL




TEST PLOT OF SPECTRAL DENSITY FOR MIDDLE CHANNEL




TEST PLOT OF SPECTRAL DENSITY FOR HIGH CHANNEL




802.11n 40 TEST RESULTTEST PLOT OF SPECTRAL DENSITY FOR LOW CHANNEL



- 1. Configure the EUT according to ANSI C63.4. The EUT was placed on the top of the turntable 0.8 meter above ground. The phase center of the receiving antenna mounted on the top of a height-variable antenna tower was placed 3 meters far away from the turntable.
- 2. Power on the EUT and all the supporting units. The turntable was rotated by 360 degrees to determine the position of the highest radiation.
- 3. The height of the broadband receiving antenna was varied between one meter and four meters above ground to find the maximum emissions field strength of both horizontal and vertical polarization.
- 4. For each suspected emissions, the antenna tower was scan (from 1 M to 4 M) and then the turntable was rotated (from 0 degree to 360 degrees) to find the maximum reading.
- 5. Set the test-receiver system to Peak or CISPR quasi-peak Detect Function with specified bandwidth under Maximum Hold Mode.
- 6. For emissions above 1GHz, use 1MHz VBW and RBW for peak reading. Then 1MHz RBW and 10Hz VBW for average reading in spectrum analyzer.
- 7. When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds. As an alternative (provided the transmitter operates for longer than 0.1 seconds) or in cases where the pulse train exceeds 0.1 seconds, the measured field strength shall be determined from the average absolute voltage during a 0.1 second interval during which the field strength is at its maximum values.
- 8.If the emissions level of the EUT in peak mode was 3 dB lower than the average limit specified, then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions which do not have 3 dB margin will be repeated one by one using the quasi-peak method for below 1GHz.
- 9. For testing above 1GHz, the emissions level of the EUT in peak mode was lower than average limit (that means the emissions level in peak mode also complies with the limit in average mode), then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions will be measured in average mode again and reported.
- 10. In case the emission is lower than 30MHz, loop antenna has to be used for measurement and the recorded data should be QP measured by receiver. High Low scan is not required in this case.



13.3. PRELIMINARY PROCEDURE OF LINE CONDUCTED EMISSION TEST

1. The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. When the EUT is a tabletop system, a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.4 (see Test Facility for the dimensions of the ground plane used). When the EUT is a floor-standing equipment, it is placed on the ground plane which has a 3-12 mm non-conductive covering to insulate the EUT from the ground plane.

- 2. Support equipment, if needed, was placed as per ANSI C63.4.
- 3. All I/O cables were positioned to simulate typical actual usage as per ANSI C63.4.
- 4. All support equipments received AC120V/60Hz power from a LISN, if any.
- 5. The EUT received charging voltage by adapter which received 120V/60Hzpower by a LISN..
- 6. The test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 7. Analyzer / Receiver scanned from 150 kHz to 30MHz for emissions in each of the test modes.
- 8. During the above scans, the emissions were maximized by cable manipulation.
- 9. The test mode(s) were scanned during the preliminary test.

Then, the EUT configuration and cable configuration of the above highest emission level were recorded for reference of final testing.


13.4. FINAL PROCEDURE OF LINE CONDUCTED EMISSION TEST

- 1. EUT and support equipment was set up on the test bench as per step 2 of the preliminary test.
- 2. A scan was taken on both power lines, Line 1 and Line 2, recording at least the six highest emissions. Emission frequency and amplitude were recorded into a computer in which correction factors were used to calculate the emission level and compare reading to the applicable limit. If EUT emission level was less –2dB to the A.V. limit in Peak mode, then the emission signal was re-checked using Q.P and Average detector.
