#### **GENERAL INFORMATION**

#### **Product Description for Equipment under Test (EUT)**

The Amgoo Telecom Co., Ltd.'s product, model number: AM523 (FCC ID: UOSAM523) or the "EUT" in this report was a Smartphone, which was measured approximately:  $145 \text{ mm (L)} \times 73 \text{ mm (W)} \times 9 \text{ mm (H)}$ , rated with input voltage: DC 3.7V rechargeable Li-ion battery or DC 5.0V from adapter. The highest operating frequency is 2480 MHz.

#### **Objective**

This test report is prepared on behalf of *Amgoo Telecom Co.*, *Ltd.* in accordance with Part 2-Subpart J, Part 15-Subparts A and B of the Federal Communication Commissions rules.

The objective of the manufacturer is to determine the compliance of the EUT with FCC Part 15 B.

#### **Test Methodology**

All measurements contained in this report were conducted with ANSI C63.4-2014, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.81 dB for 30MHz-1GHz, and 4.88 dB for above 1GHz, 1.95dB for conducted measurement.





Correction Factor = LISN VDF + Cable Loss + Transient Limiter Attenuation





The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.4-2014. The specification used was the FCC Part 15.109 Class B limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.

The system was investigated from 30 MHz to 12.4 GHz.
