

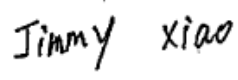

### Product Description for Equipment under Test (EUT)

The *Amgoo Telecom Co., Ltd.*'s product, model number: AM525(FCC ID: UOSAM525) or the "EUT" in this report was a *Mobile Phone*, which was measured approximately: 14.7cm (L) × 7.3cm (W) × 1.0cm (H), rated with input voltage: DC 3.7 V rechargeable Li-ion battery or DC 5.0V from adapter.

Input: AC 100-240V, 50/60 Hz, 0.2 A

Output: DC 5V, 600mA

### Objective

This test report is prepared on behalf of *Amgoo Telecom Co., Ltd.* in accordance with Part 2-Subpart J, Part 22-Subpart H and Part 24-Subpart E of the Federal Communication Commissions rules.

The objective is to determine the compliance of the EUT with FCC rules for output power, modulation characteristic, occupied bandwidth, and spurious emission at antenna terminal, spurious radiated emission, frequency stability and band edge.

### Test Methodology

All tests and measurements indicated in this document were performed in accordance with the Code of Federal Regulations Title 47 Part 2-Subpart J as well as the following parts:

Part 22 Subpart H - Public Mobile Services

Part 24 Subpart E - Personal Communication Services

Applicable Standards: TIA/EIA 603-D, ANSI C63.4-2009.

All radiated and conducted emissions measurements were performed at Bay Area Compliance Laboratories Corp. The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.91 dB for 30MHz-1GHz.and 4.92 dB for above 1GHz, 1.95dB for conducted measurement.

## **Test Facility**

The test site used by Bay Area Compliance Laboratories Corp.(Shenzhen) to collect test data is located on the 6/F, the 3rd Phase of WanLi Industrial Building, ShiHua Road, FuTian Free Trade Zone Shenzhen, Guangdong, China.

Test site at Bay Area Compliance Laboratories Corp. (Shenzhen) has been fully described in reports submitted to the Federal Communication Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on December 06, 2010. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4-2009.

The final qualification test was performed with the EUT operating at normal mode.

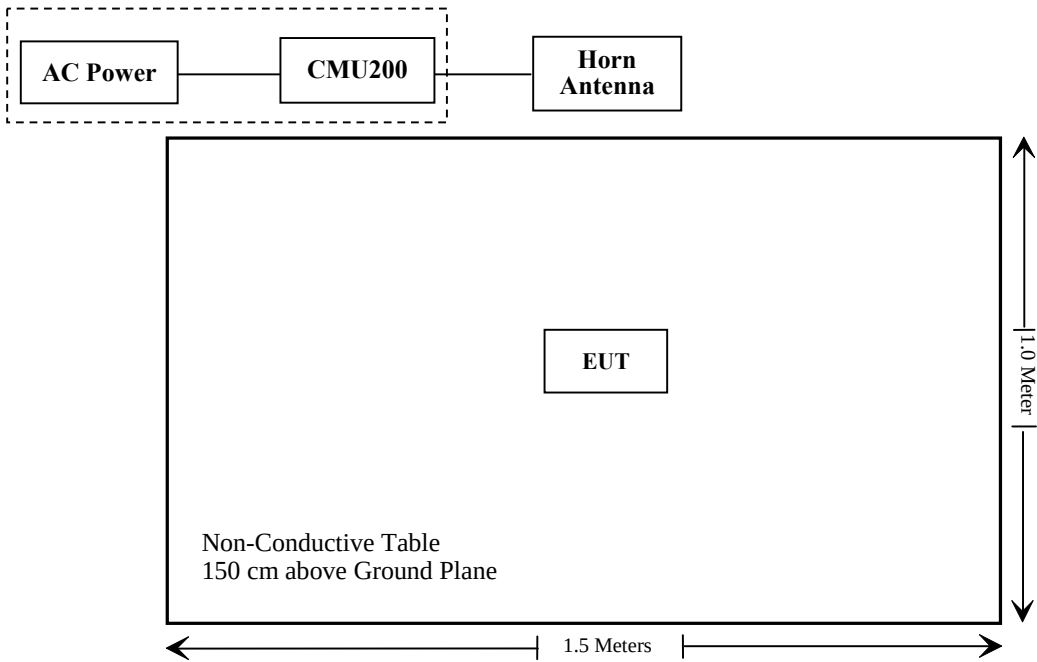
