The eight sales code labels are as follows:




Figure 1 - Sales Code label ilsz460 size is 40x25mm for model 900-620BL-US




Figure 2 - Sales Code label ilsz460 size is 40x25mm for model 900-620WT-US




Figure 3 - Sales Code label ilsz460 size is 40x25mm for model 900-630WT-US




Figure 4 - Sales Code label ilsz460 size is 40x25mm for model 900-630BL-US




Figure 5 - Sales Code label ilsz460 size is 40x25mm for model 900-640BL-US




Figure 6 - Sales Code label ilsz460 size is 40x25mm for model 900-640WT-US




Figure 7 - Sales Code label ilsz460 size is 40x25mm for model 900-650WT-US




Figure 8 - Sales Code label ilsz460 size is 40x25mm for model 900-650BL-US
