### INSTRUCTIONS:

1. Press the power button for 3 seconds, the device will flash and enter the pairing state.
2. Turn on your Smartphone's Bluetooth feature. (Refer to your Smartphone's manual on how to turn on your phones Bluetooth.
3. The Smartphone will scan for new Bluetooth devices. Pair it with the Remote Shutter's Bluetooth.
4. Open your Smartphone's camera app.
5. When you are ready for a photo. Press your respective Smartphone's camera icon button. (There are separate buttons for Android® and iOS® devices, Please ensure that you are pressing the correct button for your device.)
6. To turn off the remote shutter, Press the power button for 3 seconds. The device will flash 3 times and will turn off.
7. When not in use for 3-10 minutes the remote shutter will be in a rest state, However the battery on the remote shutter is still active. To ensure good battery life please turn off the remote shutter when not in use.

### \* NOTES:

1. Compatible with Android 4.2.2 OS and IOS 6.0 or updated OS.
2. The device supports Android 4.2.2 or newer, If the Android Smartphone does not work with the remote shutter, Please check your Android Smartphone if it supports Bluetooth Keyboard. If the Android phone does not support Bluetooth keyboard it will be unable to connect to the remote shutter.
3. Zoom function currently only supports the Samsung Galaxy S3 & S4.
4. Some third party camera app will be able to use the remote shutter, Please check with the third party camera app if it supports Bluetooth keyboard functions in order to use the remote shutter.
