The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, pre-scanned in three orthogonal panels, X, Y, Z. The worst cases (Y plane for WLAN2.4GHz + WLAN5GHz) were recorded in this report.



3.1 Unwanted Emissions Measurement

- (ii) Section 15.407(b)(4) specifies the unwanted emission limit for the U-NII-3 band. A band emissions mask is specified in Section 15.407(b)(4)(i). The emission limits are in terms of a Peak detector. An alternative to the band emissions mask is specified in Section 15.407(b)(4)(ii). The alternative limits are based on the highest antenna gain specified in the filing. There are also marketing and importation restrictions for the devices using the alternative limit.⁴

- 2. The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.
- 3. The EUT was set 3 meters from the interference receiving antenna which was mounted on the top of a variable height antenna tower.
- 4. The antenna is a broadband antenna and its height is adjusted between one meter and four meters above ground to find the maximum value of the field strength for both horizontal polarization and vertical polarization of the antenna.
- 5. For each suspected emission, the EUT was arranged to its worst case and then adjust the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading.





For radiated emissions from 30MHz to 1GHz



The low frequency, which started from 9 kHz to 30MHz, was pre-scanned and the result which was 20dB lower than the limit line was not reported.

There is a comparison data of both open-field test site and alternative test site - semi-Anechoic chamber according to 414788 D01 Radiated Test Site v01r01, and the result came out very similar.
