



2.6 Measurement Results Explanation Example

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 4.2 dB and 10dB attenuator.

Offset(dB) = RF cable loss(dB) + attenuator factor(dB). = 4.2 + 10 = 14.2 (dB)

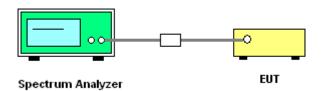
3.1.3 Test Procedures

- 1. The testing follows the ANSI C63.10 Section 6.9.3 (OBW) and 11.8.1 (6dB BW).
- 2. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.

- 3. Set to the maximum power setting and enable the EUT transmit continuously.
- 4. Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 100 kHz. Set the Video bandwidth (VBW) = 300 kHz. In order to make an accurate measurement. The 6 dB bandwidth must be greater than 500 kHz.
- For 99% Bandwidth Measurement, the spectrum analyzer's resolution bandwidth (RBW) is set
 1-5% of the emission bandwidth and set the Video bandwidth (VBW) ≥ 3 * RBW.
- 6. Measure and record the results in the test report.






6 dB Bandwidth Plot on Channel 19

6 dB Bandwidth Plot on Channel 39




6 dB Bandwidth Plot on Channel 00


6 dB Bandwidth Plot on Channel 19



99% Bandwidth Plot on Channel 00




99% Occupied Bandwidth Plot on Channel 19

99% Occupied Bandwidth Plot on Channel 39




99% Bandwidth Plot on Channel 00


99% Occupied Bandwidth Plot on Channel 19

3.2 Output Power Measurement

3.2.1 Limit of Output Power

For systems using digital modulation in the 2400-2483.5MHz, the limit for output power is 30dBm. If transmitting antenna of directional gain greater than 6dBi is used, the peak output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the antenna exceeds 6 dBi. In case of point-to-point operation, the limit has to be reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.


Low Band Edge Plot on Channel 00





Conducted Spurious Emission Plot on Bluetooth LE 1Mbps GFSK Channel 00









For radiated emissions from 30MHz to 1GHz

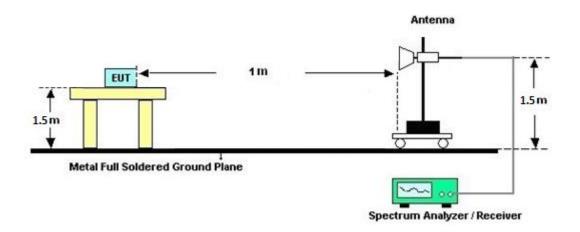


For radiated emissions from 1GHz to 18GHz


Bluetooth - LE for 1Mbps
