


# 2.3 Connection Diagram of Test System

# 2.5 EUT Operation Test Setup

The RF test items, utility "QRCT\_V3.0-00303" was installed in Notebook which was programmed in order to make the EUT get into the engineering modes to contact with base station to provide channel selection, power level, data rate and the application type and for continuous transmitting signals.

# 2.6 Measurement Results Explanation Example

#### For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

#### Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 4.2 dB and 10dB attenuator.

 $Offset(dB) = RF \ cable \ loss(dB) + attenuator \ factor(dB).$ = 4.2 + 10 = 14.2 (dB)

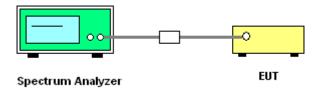


#### Channel Separation Plot on Channel 00 - 01


## Channel Separation Plot on Channel 39 - 40

#### **Channel Separation Plot on Channel 77 - 78**




## Channel Separation Plot on Channel 00 - 01


## Channel Separation Plot on Channel 39 - 40

## Channel Separation Plot on Channel 77 - 78




## Channel Separation Plot on Channel 00 - 01


## Channel Separation Plot on Channel 39 - 40

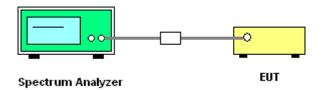


#### 20 dB Bandwidth Plot on Channel 39






#### 99% Occupied Bandwidth Plot on Channel 00


# **Hopping Mode Low Band Edge Plot**




# **Hopping Mode Low Band Edge Plot**


### 1Mbps CSE Plot on Ch 00 between 2 GHz ~ 25 GHz


### CSE Plot on Ch 00 between 30MHz ~ 3 GHz


### CSE Plot on Ch 00 between 2 GHz ~ 25 GHz




### CSE Plot on Ch 39 between 2 GHz ~ 25 GHz
