2.2 Test Mode

The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, the measured emission level of the EUT was maximized by rotating the EUT on a turntable, adjusting the orientation of the EUT and EUT antenna in three orthogonal axis (X: flat, Y: portrait, Z: landscape) and accessory (Adapter or Earphone), and adjusting the measurement antenna orientation, following C63.10 exploratory test procedures and only the worst plane, and the worst mode of radiated spurious emissions is Bluetooth 3Mbps mode, and recorded in this report.





<AC Conducted Emission Mode>





The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

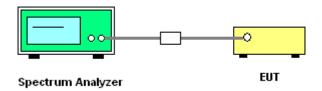

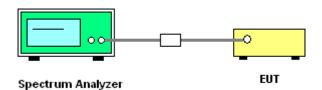



For radiated test below 30MHz



For radiated test from 30MHz to 1GHz




For radiated test from 1GHz to 18GHz

Number of Hopping Frequency



Hopping Channel Separation


