2 Test Configuration of Equipment Under Test

The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conducted emission (150 kHz to 30 MHz) and radiated emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, pre-scanned in three orthogonal panels, X, Y, Z. The worst cases (Z plane for Sample 1 and Sample 2, Y plane for Sample 3) were recorded in this report.

The final configuration from all the combinations and the worst-case data rates were investigated by measuring the maximum power across all the data rates and modulation modes under section 2.2.

Based on the worst configuration found above, the RF power setting is set individually to meet FCC compliance limit for the final conducted and radiated tests shown in section 2.3.





<WLAN Tx Mode for Sample 2>



2.7 Measurement Results Explanation Example

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 4.2 dB and 10dB attenuator.

Offset(dB) = RF cable loss(dB) + attenuator factor(dB). = 4.2 + 10 = 14.2 (dB)





3.2 Output Power Measurement

3.2.1 Limit of Output Power

For systems using digital modulation in the 2400-2483.5MHz, the limit for peak output power is 30dBm. If transmitting Antenna of directional gain greater than 6dBi are used the peak output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the Antenna exceeds 6 dBi. In case of point-to-point operation, the limit has to be reduced by 1dB for every 3dB that the directional gain of the Antenna exceeds 6dBi.







3.4 Conducted Band Edges and Spurious Emission Measurement



If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB per 15.247(d).

- 6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.

3.5 Radiated Band Edges and Spurious Emission Measurement





For radiated emissions below 30MHz




For radiated emissions from 30MHz to 1GHz







3.7 Antenna Requirements

3.7.1 Standard Applicable

If directional gain of transmitting antennas is greater than 6dBi, the power shall be reduced by the same level in dB comparing to gain minus 6dBi. For the fixed point-to-point operation, the power shall be reduced by one dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the FCC rule.

3.7.2 Antenna Anti-Replacement Construction

An embedded-in antenna design is used.

3.7.3 Antenna Gain

The antenna peak gain of EUT is less than 6 dBi. Therefore, it is not necessary to reduce maximum peak output power limit.
