a. The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, the measured emission level of the EUT was maximized by rotating the EUT on a turntable, adjusting the orientation of the EUT and EUT antenna in three orthogonal axis (X: flat, Y: portrait, Z: landscape), and adjusting the measurement antenna orientation, following C63.10 exploratory test procedures and find X plane as worst plane, and the worst mode of radiated spurious emissions is Bluetooth 1Mbps mode, and recorded in this report.





2.5 EUT Operation Test Setup

The RF test items, utility "QRCT4.0.00158.0" was installed in Notebook which was programmed in order to make the EUT get into the engineering modes to provide channel selection, power level, data rate and the application type and for continuous transmitting signals.

2.6 Measurement Results Explanation Example

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 4.2 dB and 10 dB attenuator.

Offset(dB) = RF cable loss(dB) + attenuator factor(dB). = 4.2 + 10 = 14.2 (dB)

For radiated test below 30MHz




For radiated test from 30MHz to 1GHz

Emission above 18GHz 2.4GHz BT (SHF @ 1m)




Emission below 1GHz 2.4GHz BT (LF)

- 3. DH5 has the highest duty cycle worst case and is reported.

Duty Cycle Correction Factor Consideration for AFH mode:

Bluetooth normal hopping rate is 1600Hz and reduced to 800Hz in AFH mode; due to the reduced number of hopping frequencies, with the same packet configuration the dwell time in each channel frequency within 100msec period is longer in AFH mode than normal mode.

In AFH mode, the minimum hopping frequencies are 20, to get the longest dwell time DH5 packet is observed; the on time period to have DH5 packet completing one hopping sequence is

$$2.89 \text{ ms x } 20 \text{ channels} = 57.8 \text{ ms}$$

There cannot be 2 complete hopping sequences within 100ms period, considering the random hopping behavior, maximum 2 hops can be possibly observed within the period. [100 ms / 57.8 ms] = 2 hops Thus, the maximum possible ON time:

$$2.89 \text{ ms } x 2 = 5.78 \text{ ms}$$

Worst case Duty Cycle Correction factor, which is derived from the maximum possible ON time,

$$20 \times log(5.78 \text{ ms}/100 \text{ ms}) = -24.76 \text{ dB}$$
