


Fig.2.1 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Body Side




Fig.2.2 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Body Side




Fig 3: Front side of the EUT is paralleled with flat phantom, and spacing between EUT and phantom is 4 mm.




Fig 6: Left side of the EUT is paralleled with flat phantom, and spacing between EUT and phantom is 4 mm.




Fig7: Bottom side of the Notebook is paralleled and contacted with flat phantom.




Fig 8: Top side of the EUT is paralleled with flat phantom, and spacing between EUT and phantom is 4 mm.
