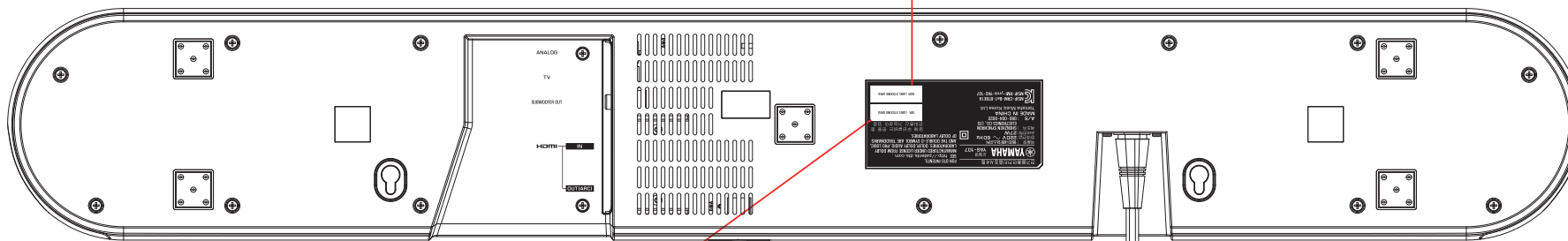

Based on the actual manufacture month, it should be shown as the previous month code and next month code. For example, the actual manufacture month is May, the Month Code should be "RT". But when the actual manufacture month is Dec, the year code should be the last code of next year, and the Month Code should be "YO".
