Please address following issues.


Q#1: As indicated in the user manual and EUT photos, two antenna connectors with a bunch of RF cable but not information about which type of antenna was connected. Moreover, there are less information regarding how the FM transmitter works. Please explain how the FM transmitter works with receiver, and provide a description about what antenna is used and how it will be installed.

And please provide antenna specification and the RF cable specification, including cable loss and length.

[SGS] Wire antenna is used for FM transmitter (BNC on one side, and open (=wire) on the other). Pls. refer to the following plot.

BNC type is connected to the transmitter. On the other point, wire type doesn't connect with anything. Details please refer to attached user manual.

Antenna specification



This device is to be used in train. Audio converter (=receiver) transfers MP3 Music to FM transmitter from PC, MP3 player etc; and then through the FM transmitter to transmit out the to FM radio.

Q#2: Please provide a block diagram with all available oscillator frequencies.
